1	MAYOR BEACH: Good Evening, everyone and
2	welcome to the Board Meeting of May 18^{th} .
3	I will ask our Attorney, Thomas Atkinson to
4	lead us in the Pledge of Allegiance. $\overline{Page \mid 3}$
5	VILLAGE ATTORNEY ATKINSON: Hand over your
6	heart.
7	(Whereupon, the Village Attorney Atkinson
8	led the Assembly in the Pledge of Allegiance.
9	After, the following ensued.)
10	MAYOR BEACH: Thank you.
11	Good Evening, everyone, welcome. Just a
12	few things, first, we are going to move the agenda
13	around a little bit, but, I just want to take a
14	moment to have a little remembrance for Alicemarie
15	Bresnihan, who served on the Lynbrook Board for
16	forty-five (45) years.
17	And, I would ask you to keep the whole
18	family in your prayers.
19	Alicemarie was big part of Lynbrook and it
20	is very sad that she past away at this time.
21	So, in your prayers, tonight, a little
22	prayer to the family. Thank you.
23	On a happier note, um, I want to
24	acknowledge Loreli Dillion for serving and
25	donating more than three hundred face masks for

1	the frontline workers.
2	Loreli is the daughter of retired Police
3	Officer, I think, he was a Sergeant, correct, Mr.
4	Dillion
5	DEPUTY MAYOR HAWXHURST: Jimmy.
6	MAYOR BEACH: Oh, yeah, Jimmy, I can't say
7	"Mr. Dillion," that was his Father and we knew of
8	him very well.
9	And, another happy note is Chief Brooks, it
10	is his birthday, today, so, Happy Birthday out to
11	the Chief, so, that is very nice for him, that is
12	a good thing.
13	As far as juggling around the agenda, I
14	would like to go down to Number 9, the sale of
15	Roxy Place and we have Counsel, here, who is
16	handling the matter.
17	This is in reference to the Terwillinger
18	and Bartone properties.
19	They are building the eighty (80) unites.
20	They are replacing the Capri Hotel and Inn
21	that building of the Capri, they wanted to
22	purchase Roxy, which would turn Roxy Place into a
23	dead end.
24	Um, the property has agreed well, the
25	majority of the Board has agreed to do that and,

1	um, they also are submitting the possibility of
2	doing a land swap with the property of 12 Saint
3	James, which they are in contract with, at the
4	Page 5
5	(Whereupon, "14" was heard calling out.
6	After, the following ensued.)
7	MAYOR BEACH: Fourteen (14), what did I
8	say, "twelve"?
9	I am sorry. I am looking at it, too.
10	This did everyone get this document and
11	everybody read it?
12	(Whereupon, "yes, Mayor" was heard. After,
13	the following ensued.)
14	MAYOR BEACH: This would be going out for n
15	appraisal for the properties.
16	The appraisal property for Roxy was, I
17	think it was sixty-four hundred square foot for
18	Roxy was five hundred thousand dollars.
19	We would consider a land exchange.
20	They are considering doing a swap of land
21	which would benefit us, I think for our parking.
22	It, um, would have to equal the five
23	hundred.
24	If it appraised over the five hundred,
25	according to the document, that would be at their

1	cost, as long as we got our five hundred.
2	If it appraised for the lower price, they
3	would make up the difference.
4	So, if the property came in at four $Page \mid 6$
5	hundred, they would make up the hundred thousand,
6	which I see as a win-win for the Village and in
7	that area we need parking
8	We do not know what is going to happen with
9	the Sterling property.
10	Our downtown needs property for parking.
11	There was an issue we did have a proposal
12	for a parking garage, which probably would have
13	helped our downtown but it became too large of a
14	project for us.
15	So, I would like to know if the Board has
16	comments on this and Marie, I will start with you,
17	if you would consider it.
18	TRUSTEE REARDON: Yes, thank you, Mayor.
19	So, if I understand, correctly, in the
20	swap, we would be able to increase parking in that
21	downtown area, correct?
22	MAYOR BEACH: Yes.
23	TRUSTEE REARDON: You know, do we have an
24	idea of how many potential spots or
25	MAYOR BEACH: I do not have it in front

of me.

I would estimate, just looking at the property, about twenty-five spots.

TRUSTEE REARDON: I think there is a direr $^{\mathrm{Page}}$ | 7 need for increased parking, especially in our downtown and we really haven't looked at many different ways and if this was a possibility, it might be an improvement for parking.

Thank you, Mayor.

MAYOR BEACH: Michael?

DEPUTY MAYOR HAWXHURST: I think when you look at the details of it, you know, we had Roxy appraised at five hundred thousand dollars, so, we will look at it and we will get an appraisal, um, now of the other property and, you know, again, for the Village, if it comes in at four hundred thousand dollars, the developer will pay us one hundred thousand.

If it comes in anything over five hundred thousand dollars, it is a win.

So, when you look at the benefits, you know, the swap of Roxy Place to make that project, you know, the fullest that it can be, getting rid of Capri is something that we have been working on for years.

1	The majority of the Board agreed to get rid
2	of the Capri and then, you know, to provide
3	additional parking in our downtown, you know, you
4	just look at it as a kind of win-win for the $\overline{{ m Page} 8}$
5	Village.
6	MAYOR BEACH: Thank you.
7	Trustee Boccio?
8	TRUSTEE BOCCIO: Pretty much the sentiments
9	of Mike and Ann Marie, so far I agree with what we
10	have heard with the common refrain has been
11	constantly from the store owners and the residents
12	is the need for more parking.
13	And, I think this kind of fits, as Mike
14	said and Ann Marie said, it is a win-win.
15	It is something that the Village should
16	certainly look to for.
17	MAYOR BEACH: Thank you. Mr. Becker?
18	TRUSTEE BECKER: Yes, thank you, Mr. Mayor.
19	I have a couple of questions. Is our
20	Counsel, here, tonight?
21	MAYOR BEACH: Excuse me?
22	TRUSTEE BECKER: Our Counsel that is going
23	to be handling, he is here. I have a couple of
24	questions mainly for Ben.
25	MAYOR BEACH: Could Counsel come down

1	to the podium.
2	COUNSEL TRUNCALE: Good Evening, Mayor,
3	Trustees.
4	MAYOR BEACH: Ben, could you announce your $^{ m Page} 9$
5	name so we have it for the record.
6	COUNSEL TRUNCALE: Benjamin J. Truncale,
7	Jr., of Counsel.
8	MAYOR BEACH: Thank you.
9	COUNSEL TRUNCALE: Special Counsel.
10	TRUSTEE BECKER: It should be noted for the
11	record, that Tom is recusing himself on this
12	matter.
13	MAYOR BEACH: Correct.
14	TRUSTEE BECKER: Is that the case, Tom?
15	VILLAGE ATTORNEY ATKINSON: That is
16	correct.
17	TRUSTEE BECKER: The property that is at 14
18	St. James Place, that is a four thousand square
19	foot lot, I believe or maybe a little bit more
20	than that?
21	COUNSEL TRUNCALE: I think it is more than
22	that, yes.
23	TRUSTEE BECKER: We are giving up a lot of
24	sixty-four hundred square feet.
25	COUNSEL TRUNCALE: Approximately, yes.

1	TRUSTEE BECKER: At the end of the day, it
2	is going to be one appraisal versus the other
3	appraisal, we are doing our appraisal?
4	$\stackrel{ ext{Page} 10}{ ext{COUNSEL TRUNCALE:}}$ What they are proposing,
5	if you referenced the letter that was sent to the
6	Village on May 6^{th} , if you referenced the letter on
7	May 6^{th} , what they are proposing, the Village
8	obtain an appraisal and they obtain an appraisal
9	and we have the two independent appraisals, um,
10	that is a mere suggestion on their part.
11	It doesn't necessarily mean that is the way
12	it has to happen.
13	But, right, now, they are in the process of
14	getting an appraisal and we are in the process of
15	getting an appraisal, as well.
16	TRUSTEE BECKER: Who is going to pay for
17	the appraisals?
18	COUNSEL TRUNCALE: They have offered to pay
19	for the appraisals.
20	TRUSTEE BECKER: For both appraisals?
21	COUNSEL TRUNCALE: Yep.
22	TRUSTEE BECKER: And, with the appraisal,
23	in particular, the property located at 14 St.
24	James Place, that has an approved building on it,
25	a couple thousand square feet, maybe not even,

um, we don't want that building right, so, we want it for a parking lot.

I would imagine that the appraisal that the appraiser is going to do is an appraisal of vacant land.

COUNSEL TRUNCALE: You know I think the parameters of how the appraiser will do it, he will apply the generally accepted rules of appraising and come up with an idea of what the value of that property is.

Um, the way that the information was conveyed to him was that the Villages contemplating, um, this land swap, perhaps but that the ultimate end goal of the Villages because I don't believe the Village would want to have a property upon it, would be to demolish that structure in order to enhance its downtown parking because it is contiguous to an existing public parking field.

TRUSTEE BECKER: Okay and, so, that appraisal, you know, maybe, perhaps to raise money, three ways it could be done, (1) by vacant land, (2) by rental fees for parking when parking space would be two hundred dollars a year, something like that, fall under the income

1	approach and then the third way would be to
2	appraise just to a comparable sale per space.
3	COUNSEL TRUNCALE: I think probably in this
4	particular instance, comparable sales might be the $^{ m Page} 12$
5	better way to go.
6	TRUSTEE BECKER: Okay, I think it is
7	important that the appraisal is based on vacant
8	land at the end of the day because there are
9	improvements there and I don't want the appraisal
10	to be misled that our intension would be to
11	purchase the property, um, our purpose of vacant
12	land would be to convert into parking space, okay.
13	COUNSEL TRUNCALE: Understood.
14	TRUSTEE BECKER: Ben, it is my
15	understanding before the portion Roxy Place can be
16	sold by the Village, it is my understanding that
17	this Board would have to first declare that
18	property surplus property.
19	COUNSEL TRUNCALE: I know which one you are
20	talking about.
21	The Board ha a Public Hearing on November
22	4 th .
23	TRUSTEE BECKER: Okay.
24	COUNSEL TRUNCALE: It is not surplus.
25	Well, I guess you could say "surplus" really the

1	Language and the Statute 20 I guess, it is
2	2001 of the Village Law says that you have to deem
3	it not of any use to the Village at that point.
4	And, the Board, I believe, you were
5	present, having a Public Hearing for the
6	discontinuance and the possible conveyance of Roxy
7	Place on November 4^{th} , I believe, you closed and
8	reserved decision but rendered a determination on
9	November 18^{th} , whereby, the Board voted
10	affirmatively in favor of discontinuing Roxy
11	Place.
12	Um, and also voted affirmatively to convey
13	the property as long as you received fair and
14	accurate consideration which is also the standard
15	contained in the Statute.
16	TRUSTEE BECKER: Okay, because my
17	understanding is this came up, obviously, after
18	the fact and it is only coming to light because
19	of this land exchange that we are talking about.
20	It is my understanding if it is not
21	feasible and I am not saying whatever we voted on,
22	whether that was a correct vote, I don't know.
23	It is not feasible to be able to declare as
24	surplus property an active road and I understand

that there is precedence on this and other

1	Villages, whereby a Village would try to declare a
2	surplus property an active road only to find that
3	it was not.
4	$_{ m Page 14}$ They were not allowed to do that vis-à-vis
5	an Article 78 Proceeding, that somebody else had
6	brought along.
7	COUNSEL TRUNCALE: I don't think that is
8	the case.
9	We did the research. We adhered to the
10	statute.
11	The Village adhered to the statute and I
12	think traffic counts were taken to see how active
13	a roadway it actually is and it was determined by
14	this Board at a duly-noted Public Hearing, it
15	wasn't any value to the Village.
16	And, they could do better by declaring it,
17	um, surplus as you say but more appropriately not
18	have any public use to the Village at this point.
19	MAYOR BEACH: Ben, one comment was just
20	made by Mr. Becker, was all the proper procedures
21	followed when we did this vote?
22	COUNSEL TRUNCALE: Yes.
23	MAYOR BEACH: Okay, thank you.
24	COUNSEL TRUNCALE: You know, I have the
25	language here, um, that the findings the Board

1	at the November 18^{th} Hearing, whereas, this strip
2	of land was not needed as a thoroughfare and so it
3	serves no useful purpose to the Village.
4	$_{ m Page} 15$ The required Notice of the Public Hearing
5	be considered, the discontinuance of the strip of
6	land and conveyance of same was published in
7	accordance with Village Law 21 I am sorry, I
8	flipped the number.
9	It was -2100 not 2001 and there were no
10	objections received from the public with regard to
11	the discontinuance of this strip of land and
12	conveyance of same.
13	And, this strip of land had a valuation of
14	five hundred thousand dollars as per the duly
15	audited appraisal that was procured by the
16	Village.
17	MAYOR BEACH: One more thing, Ben
18	COUNSEL TRUNCALE: Those were the Board's
19	findings.
20	MAYOR BEACH: The residents in that area,
21	there was not one complaint and actually people
22	wanted the idea of Roxy becoming a dead end.
23	COUNSEL TRUNCALE: I believe at the time,
24	Mayor, even though it is not required by statute,

in addition to the public notice that was put

25

1	in the paper, the Village posted, um, the property
2	and also went above and beyond and actually, I
3	believe and the Village Administrator can actually
4	Page 16
5	MAYOR BEACH: Complete transparency in that
6	area.
7	COUNSEL TRUNCALE: Yes, there is but I am
8	fairly certain that we did either hand deliver or
9	mail notice directly to all of the property owners
10	in the surrounding area.
11	VILLAGE ADIMINISTRATOR GIORDANO: Yes.
12	MAYOR BEACH: Thank you, Ben.
13	DEPUTY MAYOR HAWXHURST: I believe, if I
14	remember, two of the property owners were in
15	favor, wrote back they were in favor of it.
16	COUNSEL TRUNCALE: I would have to go back
17	to the papers.
18	TRUSTEE BECKER: I appreciate that
19	clarification.
20	This seems like a very complicated thing.
21	I know it is not as complicated as it
22	appears on this letter, but, just to be clear,
23	there is no reason why we can't sell Roxy to
24	Barton and, then, take that money and either put
25	it in the bank or at a later date purchase 14

St. James. There is no - -

COUNSEL TRUNCALE: This is no difference; the transactions are not interrelated.

 $$\operatorname{Page}\,|\,17$$ They are proposing that there be a possible land swap.

They are offering it up as a possibility to the Village but at the time that the Village had its Public Hearing and rendered the decision, it was for the sale at that time and conveyance to them, so, that is why this is here before the Board.

You received a letter and it is for this Board to vote upon it and determine whether this is something that you want to contemplate and go forward with.

on this deal, now, sit on it for now because in light of the pandemic and the financial, you know, stress that everyone is under right, now, putting five or six hundred thousand dollars in the bank account to be used to pay bills, might be a proper, prudent, um, step to take versus using it to purchase land that we could easily purchase at some point in time.

I know that building has been

1	vacant for a couple of years, now, so, um, I think
2	the building would probably be vacant at some
3	point in time, not to mention that we possibly
4	could search for other parcels that make more $ Page $ 18
5	sense than that parcel.
6	COUNSEL TRUNCALE: I hear what you are
7	asking but I don't necessarily think that is a
8	legal question.
9	That is more of a
10	MAYOR BEACH: Board decision.
11	COUNSEL TRUNCALE: A Board decision.
12	You are not asking. If you were to ask me if that
13	is a possibility, of course, that is a possibility
14	but not for me to weigh in.
15	TRUSTEE BECKER: My question, really, is we
16	don't have to do this if we don't want to?
17	COUNSEL TRUNCALE: No, of course not.
18	TRUSTEE BECKER: And, put that money and
19	put it in the bank.
20	We don't have to purchase this property at
21	this point in time and chances are it would be
22	available at some other point in time after the
23	dust settles with the pandemic.
24	COUNSEL TRUNCALE: The contemplated land
25	swap is for the Board's discretion to

1	rule on, not for me to obviously, I am just
2	conveying information.
3	TRUSTEE BECKER: Thank you, Ben. Thank you
4	very much. Page 19
5	COUNSEL TRUNCALE: Okay, no problem.
6	MAYOR BEACH: Any other comments for, Ben?
7	(Whereupon, "no" was heard. After, the
8	following ensued.)
9	COUNSEL TRUNCALE: As long as I have the
10	microphone, my wife says I love the microphone,
11	so, I may just finish.
12	MAYOR BEACH: It is where your kid gets his
13	voice from.
14	COUNSEL TRUNCALE: Um, the parameters that
15	I would propose that the Board contemplate if you
16	were to move forward
17	MAYOR BEACH: A couple of questions that I
18	have, possibly if we were was far as
19	environmental, finances, things like that
20	COUNSEL TRUNCALE: As a Village or
21	Municipality, if there would be any environmental
22	issues, I wouldn't advise that we enter into any
23	contract or land swap.
24	They would have to, once we figure out if
25	there are any and if, you know, if there

are things that need to be addressed, that they be addressed by the, um, by the applicant before we would engage in signing any contract.

The other things that I would recommend, $^{\mbox{Page}\,|\,20}$ a Municipality, you know you are exempt from the payment of property taxes.

MAYOR BEACH: Correct.

COUNSEL TRUNCALE: An exempt entity, I have seen this happen all too often where a Village either gets a dedicated piece of property that was previously on the tax rolls or enters into an agreement like this and only to find out months later that they are being given a tax bill for school taxes and the like.

MAYOR BEACH: That would not be good.

COUNSEL TRUNCALE: Any agreement that would happen, I ask the Board, that this Board consider requiring me to have language in a contract that says that the Village would be fully indemnified by the applicant with regard to any property taxes that were to happen between the time that you take title and the time that you actually get your exempt status.

MAYOR BEACH: Okay, just to review this quickly, this is an opportunity for us

1	to have an appraisal done on St. James and if it
2	came in four hundred thousand dollars compared to
3	five hundred thousand dollars for Roxy,
4	Terwilliger & Bartone would make up the $Page \mid 21$
5	difference.
6	COUNSEL TRUNCALE: Yes.
7	TRUSTEE BECKER: It is a good point, Mr.
8	Mayor, if I could jump in there, they want to make
9	up the difference with work and stuff like that,
10	would it be possible if the difference is just
11	made up with cash because at that point in time,
12	we may not want to.
13	MAYOR BEACH: That was an option, I
14	believe, correct?
15	COUNSEL TRUNCALE: Yes, this May 6th letter
16	is merely an offer.
17	You have not accepted anything, yet and I
18	believe the way they said it was it could either
19	be cash.
20	It could be in-kind services because there
21	will be fees incurred through demolish and try to
22	put that in a situation for parking or a
23	combination of the two, so, that is really for the
24	Board to determine at a later date.
25	TRUSTEE BECKER: Thank you.

1	COUNSEL TRUNCALE: And, again, that depends
2	on what the appraisal comes back at.
3	MAYOR BEACH: Any other questions?
4	(Whereupon, no response was heard. After,
5	the following ensued.)
6	MAYOR BEACH: Is there a Motion to approve
7	the applicant's request?
8	DEPUTY MAYOR HAWXHURST: So moved.
9	TRUSTEE REARDON: Second.
10	MAYOR BEACH: All in favor?
11	(Whereupon, a vote of aye was heard by all
12	except Trustee Becker who voted no. After, the
13	following ensued.)
14	MAYOR BEACH: Thank you, Ben.
15	COUNSEL TRUNCALE: Everybody safe home.
16	MAYOR BEACH: We want to make a Motion,
17	Ben, is that Motion sufficient, that covers all
18	the issues that will be worked out with the
19	attorneys?
20	COUNSEL TRUNCALE: Written agreement
21	MAYOR BEACH: We are covered
22	environmentally?
23	TRUSTEE BOCCIO: Taxes and the form of
24	which the difference would be made.
25	COUNSEL TRUNCALE: You would not enter into

1	a contract until the Village is satisfied for
2	consideration.
3	MAYOR BEACH: Ben, being away from the mic,
4	he is suggesting that the Village will not enter $^{ ext{Page} 23}$
5	into an agreement until this Board is satisfied
6	with the agreement.
7	Thank you, Counsel.
8	COUNSEL TRUNCALE: Goodnight, everybody.
9	Thank you.
10	MAYOR BEACH: Goodnight, thanks for coming,
11	Ben.
12	TRUSTEE REARDON: Thank you.
13	TRUSTEE BOCCIO: Thanks.
14	DEPUTY MAYOR HAWXHURST: Thank you.
15	MAYOR BEACH: I think I will shootdown to
16	we do have another visitor, here, to get them
17	out of the rotunda, so, I will go down to Number 3
18	on the agenda and I will ask Mr. Geier to show up.
19	So, if you could state your name and where
20	you are from, a little background and what is
21	going on.
22	BILL GEIER: My name is Billy Geier. I am
23	here with Jason Gemma and Ricky Geier.
24	MAYOR BEACH: Could you just do me one
25	favor

1	BILL GEIER: Sure.
2	MAYOR BEACH: Pull that microphone a little
3	closer to you.
4	BILL GEIER: Better? Can you hear me, now? $^{ ext{Page} 24}$
5	First, I want to thank you guys for seeing
6	us.
7	I know these are some unprecedented times
8	that we are dealing with, so, I will start by
9	thanking you guys for being here tonight.
10	As I said, my name is Billy Geier and I am
11	joined with Jason Gemma. (phonetic spelling)
12	We are the co-owners of Capital Home
13	Builders.
14	We have been in business since 2011.
15	Since our inception, we have purchased,
16	developed and sold over fifty properties in Nassau
17	County.
18	Um, Jason and I both grew up in Lynbrook
19	and graduated from Lynbrook High School.
20	Our partner, Ricky Geier is a lifelong
21	resident of Lynbrook.
22	He has been building in the area for
23	probably close to thirty years, now.
24	He has developed over twenty properties in
25	Lynbrook.

1	MAYOR BEACH: Just so we are clear of any
2	confusion, here, you are not the same Billy Geier
3	that was the Mayor?
4	BILL GEIER: No. Page 25
5	MAYOR BEACH: Okay.
6	BILL GEIER: Son of.
7	The reason we are here is to be in
8	compliance with the Village's transparency code
9	and we are here to let the Board, as well as, the
10	residents know that we are currently in contract
11	to purchase property known as 161 Union Avenue,
12	which is the corner of Scranton Avenue and Union.
13	MAYOR BEACH: Correct.
14	BILL GEIER: Over the years, there have
15	been a number of restaurants. We have seen them
16	come and go.
17	And, we felt this would be a really good
18	spot for residential development.
19	Um, we currently are examining all of our
20	options of what we could do with the property.
21	We are also in the process of, right, now,
22	finalizing our environmental testing to ensure
23	that the property is safe and suitable for
24	residential development.
25	Um, once we have a more concrete path

1	of development that we would like to pursue, we
2	are more than welcomed to host any sort of meeting
3	or get together with the residents of Lynbrook so
4	they can ask us any questions or voice any $Page \mid 26$
5	concerns that they have, maybe some suggestions
6	that they have that would help the project.
7	So, we are really here to announce that is
8	what we are looking to do.
9	These are our intension.
10	MAYOR BEACH: Thank you.
11	BILL GEIER: As we have more information,
12	we are happy to share it but that is where we are
13	at the point of the project right, now.
14	MAYOR BEACH: Okay, when do you think you
15	would be starting this transparency of letting the
16	surrounding neighbors or the Village know what is
17	going on because with the pandemic, we might have
18	to do something like outside.
19	BILL GEIER: Obviously, it is hard for us to
20	meet with attorneys and architects and stuff of
21	that nature, even the environmental testing has
22	slowed by almost a month and a half at this point,
23	so
24	MAYOR BEACH: And, realizing the fact, I am
25	sure you are under certain constraints of, you

1	know, with the contract moving it along.
2	BILL GEIER: Correct, we are working with
3	the sellers to extend our terms in order to get
4	enough of the testing and, um, our legwork done. $^{ m Page} 27$
5	Um, we are like I said, exploring more
6	options and we have started that.
7	We just don't know what the best fit is
8	right now.
9	I would hope within the next week or so, we
10	would have more information to share.
11	Um, but, I don't have a designated
12	timetable on when I will have that in front of me.
13	MAYOR BEACH: Okay, so, possibly the
14	Building Department, Brain Stanton could work with
15	you and try to get the word out and try to get
16	some kind of communication going and figure out a
17	way we could, with social distancing, get the
18	surrounding people to know what is going on.
19	That would be great, Brian, thank you very
20	much.
21	TRUSTEE BECKER: Mayor, if I could just ask
22	a question?
23	MAYOR BEACH: Of course.
24	TRUSTEE BECKER: The existing restaurant,
25	are they still around?

1	Are they going?
2	BILL GEIER: So, it is my understanding
3	that they were open prior to the pandemic, they
4	were opened, um, they are currently paying their $^{ extsf{Page} 28}$
5	rent, according to the seller.
6	(Whereupon, "they are opened for curbside,
7	pick-up and curbside delivery right, now," was
8	heard calling out from the audience. After, the
9	following ensued.)
10	MAYOR BEACH: I am sorry, what was that,
11	Mike?
12	DEPUTY MAYOR HAWXHURST: They are open for
13	curbside and pickup.
14	BILL GEIR: The seller would have to get
15	the deliver the property vacant to us, once we
16	are ready to move forward.
17	TRUSTEE BECKER: Your Dad and Uncle would
18	probably know this; it was a very famous
19	restaurant at one point.
20	It was called the King's it was a
21	very, very famous restaurant for a very long time.
22	They had very good food there. It was
23	exclusive.
24	BILL GEIER: We remember the Scranton Inn,
25	me and Jason.

1	TRUSTEE BECKER: I saw Jason in there a few
2	times, not when he was trying to make weight.
3	Thank you.
4	MAYOR BEACH: Thank you. Any questions? $^{ m Page} 29$
5	(Whereupon, no response was heard. After,
6	the following ensued.)
7	MAYOR BEACH: So, the next step is you will
8	let us know how you move forward.
9	BILL GEIER: Absolutely.
10	MAYOR BEACH: Keep in touch with my office
11	and/or the Building Department and he will inform
12	you what is going on.
13	BILL GEIER: Thank you for your time.
14	MAYOR BEACH: Thank you very much for
15	coming in.
16	TRUSTEE REARDON: Thank you.
17	MAYOR BEACH: Be safe.
18	Okay, so, I guess that we didn't even
19	do the Minutes.
20	We will start with the Minutes of April $13^{\rm th}$
21	and April 30^{th} , has everyone read the Minutes?
22	(Whereupon, "yes, Mayor," was heard. After
23	the following ensued.)
24	MAYOR BEACH: Any changes or alterations?
25	(Whereupon, "no" was heard. After,

1	the following ensued.)
2	MAYOR BEACH: Motion to accept them.
3	DEPUTY MAYOR HAWXHURST: So moved.
4	TRUSTEE BOCCIO: Second. Page 30
5	MAYOR BEACH: For the Minutes of the 13 th
6	and 30^{th} .
7	DEPUTY MAYOR HAWXHURST: Yes.
8	MAYOR BEACH: All in favor?
9	(Whereupon, a vote of aye was heard by all.
10	After, the following ensued.)
11	MAYOR BEACH: First are proclamations;
12	first, a proclamation, actually, it was last week,
13	um, is a proclamation for food allergy awareness
14	and this is really kind of upsetting when we find
15	about this.
16	We all take you don't have any
17	allergies, you tend to take life for granted, but,
18	so many kids have problems with shellfish, fish,
19	milk, eggs, nuts, peanuts, soy and wheat and we
20	just feel so bad for these people's food allergies
21	resulting in more than three hundred ambulatory
22	visits a year involving children under the age of
23	eighteen.
24	So, I know Sue Kelly and Regina Cipriano
25	TRUSTEE REARDON: Cipriano.

1	MAYOR BEACH: I didn't want to say it the
2	wrong way.
3	TRUSTEE REARDON: Yes.
4	MAYOR BEACH: They have been very active in $^{ m Page} 31$
5	trying to make people aware of this and we like to
6	be onboard with this and although this was last
7	week, May 16^{th} to the 20^{th} , I would like people to
8	realize this is a year-round thing for those
9	children.
10	It is so upsetting, you know, growing up in
11	school we use to have peanut butter and jelly
12	sandwiches all the time and, now, we can't do that
13	and it is just to be considerate of these people
14	that have this issue.
15	So, if you all are considerate of your
16	surroundings and if you are supporting these
17	children that have these allergies, it would be
18	much appreciated by everybody.
19	And, once, again, this is the proclamation
20	for them.
21	And, next we have another proclamation for
22	Seniors and, "we do hereby proclaim the month of
23	May, Senior Citizens month in the Village of
24	Lynbrook," praising the efforts of all those that

provide our older Americans the attention and

1	care they seek, congratulating our senior citizens
2	on their invaluable contributions toward
3	preserving our way of life.
4	And, once, again, you know, Lynbrook Page 32
5	wouldn't be Lynbrook without its seniors teaching
6	us what to expect in the future because they are
7	leading us and showing us how to live and we
8	appreciate all our seniors, especially, Rose, down
9	there, who is the President of the Seniors Club,
10	which is a little upsetting that we aren't allowed
11	to have our weekly meeting. Rose, this soon will
12	come to an end and we will be able to see all the
13	ladies, Grace and the other ladies.
14	Grace, I think is one hundred and three,
15	now, one hundred and two, right, now, there.
16	TRUSTEE REARDON: Yes.
17	MAYOR BEACH: We have a couple of seniors
18	that are over a hundred and we miss them dearly.
19	See you soon.
20	In addition is the transfer of funds for
21	the Fire Department.
22	Has everybody reviewed the transfer of
23	funds?
24	Any questions?
25	(Whereupon, no response was heard. After,

1	the following ensued.)
2	MAYOR BEACH: May I have a Motion to accept
3	the transfer of funds.
4	TRUSTEE BOCCIO: So moved. Page 33
5	TRUSTEE REARDON: Second.
6	MAYOR BEACH: Second.
7	MAYOR BEACH: All in favor?
8	(Whereupon, a vote of aye was heard by all.

1	Tax warrant and the collection of bills.
2	TRUSTEE BOCCIO: So moved.
3	TRUSTEE REARDON: Second.
4	MAYOR BEACH: All in favor? Page 34
5	(Whereupon, a vote of aye was heard by all
6	except Trustee Becker voted nay.)
7	MAYOR BEACH: And, next, John, why don't
8	you do the water company because you did a lot of
9	work on this.
10	VILLAGE ADMINISTRATOR GIORDANO: Yes,
11	Mayor, we worked with our municipal auditors that
12	deal with public utilities and they found that the
13	New York American Water Company shortchanged us on
14	this annual franchise payment to the Village by a

18	companies collection of revenues they collected a
19	surcharge, a State surcharge and they didn't
20	include that as revenue when they calculated their
21	fee to the Village.

25	point we are recommending that the Board receive

1	the refund.
2	MAYOR BEACH: Thank you, John.
3	Motion to accept?
4	TRUSTEE BOCCIO: So moved. Page 35
5	TRUSTEE REARDON: Second.
6	MAYOR BEACH: All in favor?
7	(Whereupon, a vote of aye was heard by all.
8	After, the following ensued.)
9	TRUSTEE BECKER: Mr. Mayor, if I could,
10	just go back to Item 4-C, I just want to make sure
11	my vote on that is recorded as, "no."
12	MAYOR BEACH: Okay.
13	TRUSTEE BECKER: 4-C.
14	MAYOR BEACH: John, do you have that?
15	VILLAGE ADMINISTRATOR GIORDANO: Yes.
16	MAYOR BEACH: Okay, then, there is a legal
17	Notice to change the Meeting of June $1^{ m st}$ and June
18	$15^{ m th}$ to do the reschedule meeting of just June $15^{ m th}$,
19	I need a Motion for this Legal Notice.
20	TRUSTEE BOCCIO: So moved.
21	TRUSTEE REARDON: Second.
22	MAYOR BEACH: All in favor?
23	(Whereupon, a vote of aye was heard by all.
24	After, the following ensued.)
25	MAYOR BEACH: Did everyone say "aye"?

1	(Whereupon, "aye" was heard by all.)
2	MAYOR BEACH: Mr. Stanton, can you help me
3	with the next one.
4	SUPERINTENDENT STANTON: Yes. Page 36
5	MAYOR BEACH: Thank you for coming Brian.
6	I try to have these Department Heads stay
7	out, you're such a vital person to Lynbrook.
8	It is good that you are here to explain a
9	few things, especially, you know, if there are any
10	questions about anything that just came up.
11	Thank you for being here.
12	SUPERINTENDENT STANTON: Regarding this
13	next process
14	MAYOR BEACH: Request for the sidewalk
15	scaffold at the High School.
16	SUPERINTENDENT STANTON: Patriot
17	Construction has requested permission to put a
18	sidewalk shed approximately eighty feet as they
19	are redoing the front façade of the High School.
20	This sidewalk shed will protect the
21	pedestrians from anything that falls and it is
22	standard procedure.
23	But, 212-3 of our Village Code, it is
24	subject to your approval.
25	At this present time, we have a building

1	permit along with all proper insurances to erect a
2	sidewalk shed.
3	It will be, approximately, eighty feet long
4	and it should be up sometime around the New Year. $\overline{Page \mid 37}$
5	Um, there has to be protection.
6	Everything, the crosswalk will still be open.
7	Any fire apparatus will still have access
8	to any hose connection.
9	So, there is not issue of that nature.
10	So, what I am requesting is the Board to
11	consider approval of erecting the sidewalk shed.
12	There will be lighting underneath, as per
13	State Code.
14	So, it won't be dark.
15	TRUSTEE BOCCIO: How long is that expected
16	to be up?
17	SUPERINTENDENT STANTON: Approximately,
18	through the New Year.
19	TRUSTEE BOCCIO: Through the New Year?
20	SUPERINTENDENT STANTON: Yes.
21	DEPUTY MAYOR HAWXHURST: Does our permit
22	have an end date or is it open-ended?
23	SUPERINTENDENT STANTON: I am requesting it
24	be open-ended because it won't make sense to take
25	down the whole purpose is to safeguard.

VIEDAGE OF DIAMPOT INCOTEES 3/10/20
They are projecting around the New Year.
So far we are on target. It will come down
but we can work with Patriot Construction and when
there is no need for it to be up and it is safe $^{ m Page} 38$
for the students to go in and out of the school,
maybe we will request to take it down, too.
DEPUTY MAYOR HAWXHURST: I would be happy
with it having an end date and they can come back
in a couple months before to request an extension
rather than open-ended and we see it is still up
in June.
It is noted in the letter that was
submitted to the New Year, so, if you would like
to give it to mid January of 2021, January $15^{ ext{th}}$ of
2021, that is what that letter was stating, if
that is acceptable?
DEPUTY MAYOR HAWXHURST: Yeah, I mean,
whether it is the $15^{\rm th}$ or the $31^{\rm st}$, just so there is
an end date, so, it is not dragging on, sometimes
you see it in the City.
If they need it, they can come back to us
for an extension, that is fine.
Being that it is up through the Winter
months, is there any kind of consideration for

snow or ice, um, on the structure?

1	SUPERINTENDENT STANTON: Nothing else
2	changes with the walkway beneath it.
3	They still have to plow it and keep it
4	clear for pedestrians. Page 39
5	DEPUTY MAYOR HAWXHURST: No, I mean on the
6	structure, itself?
7	SUPERINTENDENT STANTON: The whole purpose
8	of the sidewalk bridge scaffold is for load
9	capacity, so, whatever is on top of it, any snow
10	on it would not be a concern, the weight or
11	anything of that nature.
12	MAYOR BEACH: Who is responsible for the
13	snow removal?
14	SUPERINTENDENT STANTON: Um, that would be
15	the contractor.
16	MAYOR BEACH: Not the school?
17	SUPERINTENDENT STANTON: The contractor or
18	the school, whoever maintains that sidewalk.
19	MAYOR BEACH: Okay, I am sure they will for
20	the concern of the children, okay.
21	DEPUTY MAYOR HAWXHURST: The shed will be
22	completely on the sidewalk; it doesn't extend to
23	the street?
24	SUPERINTENDENT STANTON: No, we are not
25	going into the street.

1	When I went out to the field, it will start
2	over by to the East side of the school like
3	where that opening goes all the way to Roosevelt
4	and head toward Hewlett and the width of those $^{ m Page} 40$
5	sidewalks over there, Trustee, it would not be in
6	the way of the hydrants or the street or anything
7	like that.
8	DEPUTY MAYOR HAWXHURST: Do we know if the
9	shed underneath the shed is it going to be one
10	width?
11	Is it going to be like two lanes under the
12	shed?
13	SUPERINTENDENT STANTON: It usually comes
14	in a six-foot width walkway path that is usually
15	the path, if you recall or the sidewalk shed was
16	put up at the movie theater.
17	DEPUTY MAYOR HAWXHURST: Okay, so, a
18	wheelchair or anything like that can get through
19	there?
20	You want to make sure a wheelchair
21	SUPERINTENDENT STANTON: No problem.
22	DEPUTY MAYOR HAWXHURST: In a worse-case
23	scenario, a stretcher, if it was to get in there,
24	there is room for a stretcher to get in and things
25	like that?

1	SUPERINTENDENT STANTON: All the
2	entranceways and everything is going to be
3	addressed in the setup.
4	DEPUTY MAYOR HAWXHURST: Okay. Page 41
5	SUPERINTENDENT STANTON: So, again, first
6	responders will have full access with.
7	MAYOR BEACH: That is a good point. Brian
8	will have the Fire Chief down there.
9	SUPERINTENDENT STANTON: I can have him go
10	down as they erect it.
11	MAYOR BEACH: I would like the Police Chief
12	and the Fire Chief down there to evaluate it.
13	SUPERINTENDENT STANTON: With the Police
14	Chief, I will have a second meeting with the Fire
15	Chief.
16	MAYOR BEACH: Thank you. Thank you.
17	DEPUTY MAYOR HAWXHURST: Thank you, Brian.
18	MAYOR BEACH: Any other questions for
19	Brian?
20	(Whereupon, no response was heard. After,
21	the following ensued.)
22	MAYOR BEACH: I have one.
23	Brian, we have been talking about our
24	restaurants, the outdoor dining, the Town of
25	Hempstead has passed the outside dining well,

1	they are going to do an outside dining, as soon
2	as, the Governor allows it.
3	I am for outside dining and I have asked
4	you to review that and do you have a report that
5	you can give to the Board?
6	SUPERINTENDENT STANTON: Yes, at this
7	present time, what we are going to do with the
8	Board's approval is permit outdoor dining so
9	restaurants and eateries can use their parking
10	lots.
11	And, this Board will pick out certain areas

24	for safety, it will help.

We will approve it and then this Board,

1	based upon their determination of what nights and
2	the timelines, as I know you guys are going to
3	come up with that kind of criteria, once you
4	finalize that we will put it on the permit online. $^{ m Page} 43$
5	And, it will be ready for them to go once
6	they open it up.
7	MAYOR BEACH: I also like the Board to
8	consider, um, of course, in concert with the
9	Chamber, that we would allow the shutdown of
10	Atlantic Avenue for some of the restaurants and
11	utilization of some parking lots that some of the
12	restaurants might have to be able to set up their
13	tables, is there any comment on that?
14	DEPUTY MAYOR HAWXHURST: No, I think it is
15	a good idea to look at.
16	Listen, the restaurants are struggling even
17	though they have takeout business or curbside,
18	pickup, you can walk in and get something to go,

22	opportunity to succeed, because it is a benefit
23	for all of our residents.
24	It is a benefit for them. So, looking at,

with Brian, okay, with regard to set up and safety

10	MAYOR BEACH: Ann Marie?
11	TRUSTEE REARDON: I agree with the Deputy
12	Mayor, um, is that I think it is important that we
13	offer something to our local businesses and our
14	restaurants as this is lifted, so, I would
15	absolutely give you the authority to do that.
16	MAYOR BEACH: Thank you. Trustee Boccio?

20	And, there really will be no gathering.
21	There will be a small group at the Dough

24	we must recognize our Veterans.
25	I realize people will come out and possibly

1	wave to the Veterans as they pass in the cars but
2	I would ask those people not to gather and keep
3	the six feet from each other and have your masks
4	on. Page 51
5	This is a good thing that we are doing.
6	Let's not ruin it. I ask you to, please,
7	follow the CDC guidelines and I am sure the
8	Veterans would appreciate you acknowledging them.
9	So, please, let's work together on this and
10	give the Vets the recognition that they deserve.
11	Thank you and that will be starting on
12	observance of Memorial Day.
13	Veterans Day is in November, that is
14	another thing we are working on for the $75^{ m th}$
15	Anniversary that past for World War II.
16	Um, that it will start at 7:00 a.m. at the
17	usual parade route.
18	And, now, we are down to, let me see 10-A
19	is the Grant projects.
20	Now, John, has been submitting many Grants
21	for us and I thought I just give you a breakdown
22	of what is going on because due to the pandemic,
23	some of the things have been postponed but we have
24	a list of Grants that we are sitting and waiting
25	for.

1	5 Corners Park, that is by the Citibank
2	that is a seventy-five-thousand-dollar Grant from
3	Gaylor.
4	Merrick Road Gateway, that was the $Page \mid 52$
5	entranceway that we were going to do into our
6	Village, that is another seventy-five-thousand-
7	dollar Grant from Legislator Gaylor, that was
8	supposed to come through September.
9	The other Grant that I mentioned, first,
10	looks like, now, it is going to come in July, that
11	was also supposed to come last year.
12	Um, the three southeast Parks, seventy-five
13	thousand dollars from them from Legislator Gaylor,
14	that was supposed to come in December of 2019, we
15	are waiting for that.
16	The two southwest Parks, um, that was
17	Kaminsky, Senator Kaminsky, that is for sixty-five
18	thousand dollars
19	There is a little league and hockey Grant
20	for fifty thousand dollars from Kaminsky that is
21	estimated to be in August of 2020.
22	Sunrise, the North side of Sunrise, the
23	path is one hundred-dollar chips, that is supposed
24	to be in April.
25	Scranton Avenue has been taken care of.

1	Peninsula Boulevard Path, that was
2	completed in April 2019, we were supposed to get
3	three police cars, one hundred and twenty thousand
4	dollars from Kaminsky, that is estimated to be in $Page \mid 53$
5	February.
6	The walk-thru, we are possibly getting, we
7	have a Grant for that if we should move forward of
8	one hundred and fifty and two hundred thousand
9	dollars and that was supposed to be in June of
10	2020.
11	36 Carpenter Avenue is another Grant.
12	It is pending at the end of this month and
13	that one hundred and fifty thousand dollars.
14	The LED streetlights, that is pending also
15	for the end of May, that is fifty thousand
16	dollars.
17	The Fire Department air packs, two thousand
18	dollars from FEMA
19	TRUSTEE REARDON: Two hundred thousand
20	dollars.
21	MAYOR BEACH: Two hundred thousand dollars,
22	I am sorry.
23	My mouth is starting to get dry, pending in
24	December of 2020.
25	Streets, we got four hundred and thirty-

1	nine thousand and that is, um,
2	VILLAGE ADMINISTRATOR GIORDANO: COVID.
3	MAYOR BEACH: All from COVID, right,
4	possibly and the payroll, COVID, three million one $^{\mbox{Page} 54}$
5	hundred and eighty-nine thousand and that has been
6	denied, so, we are still working on that.
7	And, the COVID revenue loss is one million
8	two hundred thousand, that is from the CARES Act
9	and that is pending in July of 2020 and the COVID
10	expenses to be announced that we get seventy-five
11	percent from FEMA and we are supposed to get
12	twenty-five from the State.
13	So, it is all pending in July.
14	The office staff has been extremely busy
15	trying to get these things done, accomplished.
16	We are in constant contact with Mr. Gaylor
17	and Mr. Kaminsky.
18	It has becoming a waiting game and it is
19	becoming a long waiting game.
20	TRUSTEE BECKER: Mr. Mayor, quick question,
21	the Turf Filed at Greis Park is there any Grant
22	money achieved for the Turf Field?
23	MAYOR BEACH: No, there is a bond on that.
24	We are still working on possible grants
25	that we could utilize for that.

1	TRUSTEE BECKER: Do we have an estimated
2	total cost on that?
3	MAYOR BEACH: Was it a million six,, was
4	it, originally?
5	VILLAGE ADMINISTRATOR GIORDANO: Yes.
6	TRUSTEE BECKER: We are still a million
7	dollars away?
8	MAYOR BEACH: A few bucks, okay.
9	Any other questions?
10	Next on the agenda, I have Nassau County
11	Urban Consortium that is a three-year agreement
12	and CDBG.
13	I like to see people say that four times
14	fast.
15	A Motion to accept that for a three-year
16	agreement to renew it.
17	TRUSTEE BOCCIO: So moved.
18	TRUSTEE REARDON: Second.
19	MAYOR BEACH: All in favor?
20	(Whereupon, a vote of aye was heard.
21	After, the following ensued.)
22	MAYOR BEACH: And, then, I have the bills.
23	TRUSTEE BOCCIO: Yes, Mayor, I believe that
24	the bills listed on the abstract and audited
25	vouchers be paid as soon as they have been

1	duly audited by the Majority.
2	TRUSTEE REARDON: Second.
3	MAYOR BEACH: All in favor?
4	(Whereupon, a vote of aye was heard by all:
5	After, the following ensued.)
6	VILLAGE ADMINISTRATOR GIORDANO: The drive-
7	in.
8	MAYOR BEACH: Excuse me, the drive-in, I am
9	getting to that.
10	I have two more things to cover and it
11	would be in weekends coming, Friday, we have a
12	drive-in coming to Greis Park.
13	There would be two shows, I believe, the
14	first one is at 8:30 and the next one would be at
15	11:30.
16	I understand the 8:30 has been sold out
17	already.
18	It took about an hour and it went.
19	I am not I cannot tell you what the
20	movie is as of yet because of legalities but I
21	should be able to release that tomorrow. I am
22	sorry.
23	People just want to get out. They don't
24	even know what the movie is and it sold out, which
25	is great not sold out, it is for free.

1	It is being sponsored by the New Vision
2	Party, the Chamber of Commerce and the
3	Incorporated Village of Lynbrook which is nice that
4	everybody is participating. Page \mid 57
5	It makes the possibility that we can do it,
6	again.
7	I think it is a great thing for the
8	Village.
9	The vehicles will be coming in from Horton
10	Avenue.
11	We anticipate having people line up down
12	Horton down Sunrise and then we open the gates,
13	then people will filter in on Horton and they will
14	be put in parking spots.
15	It will be every other spot.
16	We are going to keep the social distancing
17	with the cars.
18	The cars will be staggered. We have
19	decided that larger vehicles will go to the rear
20	because we don't want to have a big SUV right in
21	the middle blocking the little guy in one of those
22	little Hondas.
23	Hondas are even big, now, one of those
