1	MAYOR BEACH: Good Evening, everyone and
2	welcome to the Board Meeting of September 14^{th} .
3	I will ask Deputy Mayor Hawxhurst to lead
4	us in the Pledge of Allegiance. $\overline{Page \mid 3}$
5	DEPUTY MAYOR HAWXHURST: Hand over your
6	heart.
7	(Whereupon, Deputy Mayor Hawxhurst led the
8	Assembly in the Pledge of Allegiance.)
9	MAYOR BEACH: Welcome, everyone. I hope
10	everyone is weathering the pandemic. It looks
11	like things are moving along.
12	The first item on the agenda are the
13	Minutes. Has the Board reviewed the Minutes?
14	(Whereupon, "Yes" was heard from all Board
15	Members. After, the following ensued.)
16	MAYOR BEACH: Any changes, alterations?
17	(Whereupon, "No, Mayor" was heard. After,
18	the following ensued.)
19	MAYOR BEACH: A Motion to move the Minutes?
20	TRUSTEE BECKER: So moved.
21	TRUSTEE REARDON: Second.
22	(Whereupon, a vote of aye was heard by all
23	except for Deputy Mayor Hawxhurst who abstained.)
24	MAYOR BEACH: Next, Item 2, on the agenda is
25	the rescheduling of the Board Meeting to October

1	19 th .
2	DEPUTY MAYOR HAWXHURST: So moved.
3	TRUSTEE REARDON: Second.
4	MAYOR BEACH: All in favor?
5	(Whereupon, a vote of aye was heard by all.
6	After, the following ensued.)
7	MAYOR BEACH: Then we have an opportunity
8	to replace some lighting.
9	John, you want to speak about this?
10	VILLAGE ADMINISTRATOR GIORDANO: Yes, PSEG
11	are offering efficient lighting.
12	PSEG is offering incentives on replacing
13	indoor lighting with energy efficient lighting and
14	we ran some numbers on some sample lights and we
15	found, eve n though we upgraded the lights several
16	years ago with the new LED lights, they do save,
17	um, an amount of energy.
18	The payback period is less than two years,
19	so, because the replacement project has exceeded
20	the threshold, we recommend that we actually go
21	out for competitive bids to get prices for all
22	five building prices.
23	MAYOR BEACH: So, what you are saying is it
24	would pay for us to move forward with doing the
25	fixtures all over, again and we would save money.

1	VILLAGE ADMINISTRATOR GIORDANO: That is
2	correct.
3	MAYOR BEACH: So, a Motion to receive bids?
4	TRUSTEE REARDON: So moved. Page 5
5	DEPUTY MAYOR HAWXHURST: Second.
6	MAYOR BEACH: All in favor?
7	(Whereupon, a vote of aye was heard by all
8	Board Members. After, the following ensued.)
9	MAYOR BEACH: Thank you, John.
10	Next on the agenda is 152, Davison Avenue
11	requesting to have chickens.
12	A neighbor on Davison that is looking to
13	have request a permit to have chickens in
14	their backyard.
15	They are looking to have four hens, this
16	year with a possible expansion of six next year.
17	The coop, we have been looking at is five
18	feet wide, seven feet long, measurements include
19	the house and a run and pen enclosure.
20	Our backyard is fully fenced.
21	They would only be allowed to roam the
22	backyard when we are outside with them.
23	Um, I guess I will go to the Board Members,
24	then, have a little feedback.
25	Mr. Becker?

1	TRUSTEE BECKER: Mr. Mayor, these types of
2	issues are of concern because it could
3	MAYOR BEACH: With that being said, let's
4	go to, Counsel, let's get feedback from him. $Page \mid 6$
5	VILLAGE ATTORNEY ATKINSON: Thank you,
6	Mayor.
7	Mayor, if you recall, this matter was on a
8	number of months ago, um, an application was made
9	under Section 69 of the Lynbrook Village Code.
10	Section 69 of the Lynbrook Village Code
11	speaks to keeping of certain animals.
12	It restricts certain animals, but, then, it
13	also does provide the Village Board with an
14	opportunity to okay certain animals under the
15	guidance, if an application is made by a resident.
16	In this case, residents, the owners of 152
17	Davison Avenue has requested to keep chickens in
18	their backyard.
19	I do recall we had a similar application
20	about two years ago, I think it was my first year
21	as Village Attorney and, um, this application is
22	similar for the Board.
23	We did discuss this at length last time.
24	I don't believe we need to go into it in
25	length at this time but Section 69, um,

1	comprises eleven (11) different Sections.
2	The first, I would say, eight (8) are more
3	applicable to the matter at hand but one of the
4	$_{ m Page} 7$ Sections does provide some insight into the issues
5	that the Board would consider with regards to
6	maintaining the chickens.
7	Section 69 (5) speaks to restrictions upon
8	issuing the permit and what the Board would weight
9	is the health, peace, quiet and order of the
10	Village in, um, making this decision.
11	I would note on a personal level that by
12	far in my five years as Trustee, four years as
13	Judge and, now, blessed in my third year as
14	Village Attorney, there has never been an issue
15	that garnered more comments from the public to me,
16	personally, than, um, the issue at hand.
17	So, um, if you guys have any questions, if
18	you just want to go to Trustee Becker, it is the
19	Mayor's prerogative.
20	MAYOR BEACH: I do see I don't know
21	when the date was on Hollywood Avenue, when that
22	was denied.
23	I don't know the date.
24	Was it three years ago? Four years ago?
25	It was denied.

1	TRUSTEE REARDON: Two.
2	VILLAGE ATTORNEY ATKINSON: I was in my
3	first year as Village Attorney. I know I did a
4	little bit of it. Page 8
5	I have a recollection of that, that would
6	have been 2019, most likely or 2018, later 2018.
7	MAYOR BEACH: I will go back to Mr. Becker.
8	TRUSTEE BECKER: Thank you, Mr. Mayor.
9	So, Tom, just to be clear, it is up to the
10	Board to approve or disapprove this?
11	VILLAGE ATTORNEY ATKINSON: That is
12	correct, Mr. Becker, so, any chickens, ducks,
13	rabbits, pigeons, reptiles, rodents or similar
14	animals or fowl needs Board approval.
15	So, this is squarely within that provision.
16	TRUSTEE BECKER: Residents, homeowners do
17	not have the right to have, let's just say,
18	chickens, for that matter, without this Board's
19	approval or Zoning Board?
20	How does that work?
21	VILLAGE ATTORNEY ATKINSON: Village Board,
22	Section 69 (2), specifically says "Village Board,"
23	so
24	TRUSTEE BECKER: Okay.
25	And, the last applicant was denied?

1	VILLAGE ATTORNEY ATKINSON: Yes, it was.
2	TRUSTEE BECKER: Did we have a reason for
3	that denial?
4	VILLAGE ATTORNEY ATKINSON: To be honest, I
5	didn't go back and pull the Minutes for that.
6	TRUSTEE BECKER: Okay.
7	VILLAGE ATTORNEY ATKINSON: You know
8	TRUSTEE BECKER: Because in reviewing the
9	submission, um, it did look very professional. It
10	seems like this is something that they are
11	professional with and, um, you know, I would guess
12	that should there be any concerns or issues down
13	the road with residents, their neighbors, um, that
14	they would, obviously, professionally address
15	those issues of those neighbors.
16	I am mostly concerned about the noise and
17	potentially an odors but, mostly the noise since
18	those noises can carry quite far, um, but if we
19	denied it once before, I think did we
20	establish a precedence with that, at this point?
21	VILLAGE ATTORNEY ATKINSON: I would view
22	them as different applications, I think part of
23	what you are saying is correct in that this
24	application, I believe, the husband/owner is a
25	Veterinarian and his wife is a Vet. Tech.

1	TRUSTEE BECKER: Right.
2	VILLAGE ATTORNEY ATKINSON: Or Veterinary
3	Assistant, so, this is a little bit of a different
4	application. Page 10
5	The threshold for the application before
6	you is it okay to keep chickens in the backyard or
7	not, you know within the coop that they outlined
8	in their application?
9	And, then the second question you would
10	have would be any restrictions that you would want
11	to place if the answer is yes to that and you go
12	further and what restrictions would you want to
13	place upon it pursuant to 69 (50).
14	TRUSTEE BECKER: That is all, Mr. Mayor.
15	MAYOR BEACH: That's it, good.
16	Comments?
17	TRUSTEE BOCCIO: I think the major concerns
18	are going to be odor, sound, um, and my concern is
19	that while these might be professional
20	Veterinarians that are familiar with animals, the
21	question is where do you draw the line with
22	respect to judging one's ability to take care of
23	animals based upon their profession or not.
24	It could be farmers, it could not be and if
25	we deny it, if we approve it, what do we do with

1	the next one where somebody may not be a
2	Veterinarian but they grew up on a farm and they
3	are just as capable.
4	The point is I am leery of going forward $^{ m Page} 11$
5	with having that kind of potential nuisance in the
6	area.
7	I know I wouldn't want it in my
8	neighborhood.
9	I know of other situations on South
10	Sunrise, a situation where the smell has been
11	pretty bad.
12	People have complained and I know of other
13	areas.
14	So, um, those are my concerns.
15	TRUSTEE BECKER: Mr. Mayor, could I ask a
16	question.
17	Tom did anybody look into the COVID-19
18	component of this?
19	Are chickens more susceptible to COVID-19?
20	Does the pandemic have any relevance, here?
21	VILLAGE ATTORNEY ATKINSON: I did not look
22	into the transmit-ability of COVID-19 via chickens
23	to humans, that is fair.
24	TRUSTEE BECKER: That has been quite a
25	concern with a lot of people with the

1	Pandemic is the ability for the virus to jump from
2	animals to humans, that maybe how it started. I
3	am not sure.
4	MAYOR BEACH: Deputy Mayor? Page 12
5	DEPUTY MAYOR HAWXHURST: I have not
6	questions.
7	TRUSTEE REARDON: You know what, I am just
8	going to take a second to agree with Trustee
9	Boccio.
10	My concern is, um, is just four chickens,
11	possibly six in a backyard that is not a large
12	backyard and abutting up to the neighbors and you
13	know there is a concern for the smell and the
14	noise and just the clear lack of space.
15	MAYOR BEACH: At this point, then, I would
16	ask for a Motion, to make a Motion for a vote
17	whether to allow it or not.
18	TRUSTEE BECKER: Mr. Mayor, if I could, I
19	hate to put this off, again, would it be possible
20	to take this for the time-being and find out a
21	little bit more if there is any recommendation
22	from the New York State Health Department or the
23	Nassau County Health Department with respect to
24	livestock in people's backyards during the

pandemic?

1	VILLAGE ATTORNEY ATKINSON: I would say,
2	while I haven't reviewed the Governor's directives
3	in connection, specifically, with this, it would
4	be safe to say that I don't believe Governor Page 13
5	Cuomo's directive spoke, particularly to chickens
6	in a backyard and the commutability of COVID-19.
7	TRUSTEE BECKER: Yeah, I mean I think
8	further analysis by the Nassau County Health
9	Department or just a quick phone call to the
10	Nassau County Health Department or the New York
11	State Health Department would be prudent, you
12	know, just to make sure that we have crossed our
13	"T's" and dotted our "I's".
14	TRUSTEE REARDON: Does the Health
15	Department have any input to say about these types
16	of animals in resident homes not just COVID?
17	VILLAGE ATTORNEY ATKINSON: I don't know
18	the answer to that.
19	TRUSTEE BECKER: I can answer that, they
20	definitely do when there are issues in homes.
21	TRUSTEE REARDON, Yes, a board approval, I
22	am saying.
23	It is Board approval to make the decision
24	if we are going to allow the permit, does the
25	Board of Health have any insight to our Board

1	approval?
2	That is my question. Not after, then it is
3	a problem.
4	VILLGE ATTORNEY ATKINSON: The initial $Page \mid 14$
5	threshold question for the Board is yes or no on
6	chickens.
7	If the answer is yes, we can go forward
8	with whatever restrictions you would like to place
9	on that having to do with the Department of Health
10	or noise sound barriers, sanitation, etc.
11	If the answer is no, initially, then, um,
12	the answer would be no.
13	MAYOR BEACH: I think we should have a
14	vote, here and be over with it.
15	This has been going on for some time, now.
16	There was a vote made last time. We don't
17	happen to know what that vote was, do we, the last
18	time it was a majority of no, nay, I would
19	believe.
20	TRUSTEE BECKER: It was tabled last time.
21	TRUSTEE REARDON: On Hollywood.
22	DEPUTY MAYOR HAWXHURST: If I remember, the
23	answer was no, unanimously.
24	TRUSTEE REARDON: Yes, by this Board
25	sitting, here.

1	TRUSTEE BOCCIO: I make a Motion to deny
2	the chickens.
3	TRUSTEE REARDON: I second it.
4	MAYOR BEACH: All in favor?
5	(Whereupon, a vote of aye was heard by all
6	Board Members. After, the following ensued.)
7	MAYOR BEACH: Done. Thank you to the
8	Board.
9	VILLAGE ATTORNEY ATKINSON: Mayor, if it is
10	okay, I will stay up, here for "3-C" and "D", as
11	well. "3-C," actually, it is an application
12	before the Board.
13	MAYOR BEACH: You're staying up there for
14	"C" and "D."
15	VILLAGE ATTORNEY ATKINSON: "D", most
16	respectfully, Mayor.
17	MAYOR BEACH: You know what, "D" is the
18	Kiwanis Club.
19	TRUSTEE REARDON: Yes.
20	MAYOR BEACH: And, they rescinded their
21	request.
22	VILLAGE ATTORNEY ATKINSON: Right and "C"
23	was the application for Field 20.
24	MAYOR BEACH: That is gathering. They have
25	to support a family member, a police officer.

1	VILLAGE ATTORENY ATKINSON: That is
2	correct, Mayor, without including, if the Board
3	did deem that they would like to approve this, I
4	would ask that you give myself the latitude to go
5	back and forth with the gentleman who made the
6	application to ensure that they have met the
7	guidelines set forth by the Department of Health;
8	social distancing, masking, etc.
9	Also, we are in Phase 4, there is a fifty-
10	person limit for social gatherings, that the
11	Governor has set forth.
12	MAYOR BEACH: That gathering being less
13	than fifty.
14	VILLAGE ATTORNEY ATKINSON: That is
15	correct.
16	MAYOR BEACH: And, keeping their social
17	distancing and they want to utilize parking Field
18	20 behind F & L and utilizing half the parking
19	lot.
20	They will not be using the whole parking
21	lot, I believe that is what was presented to us
22	and it was from 3:00 p.m. to 6:00 p.m., the
23	reduced time, so, I would request, Counsel, be
24	allowed to keep the communication going and as

long as he certifies everything is going to our

25

1	request that we permit it.
2	DEPUTY MAYOR HAWXHURST: So moved.
3	TRUSTEE REARDON: Second.
4	MAYOR BEACH: All in favor?
5	(Whereupon, a vote of aye was heard by all
6	Board Members. After, the following ensued.)
7	VILLAGE ATTORNEY ATKINSON: Thank you,
8	Mayor.
9	MAYOR BEACH: We going back to 3-B which is
10	the request for illumination of John Street near
11	the Valley Stream it is funny to say that, but
12	the Valley Stream Bike Shop in Lynbrook on the
13	corner, there, that side street is extremely dark
14	and I am recommending that we put a streetlight
15	there at that location.
16	TRUSTEE BECKER: So moved.
17	TRUSTEE BOCCIO: Second.
18	MAYOR BEACH: All in favor?
19	(Whereupon, a vote of aye was heard.
20	After, the following ensued.)
21	MAYOR BEACH: Thank you.
22	And, then we have Item Number 4 is an
23	appointment of a Town Clerk.
24	DEPUTY MAYOR HAWXHURST: We skipped on
25	MAYOR BEACH: Yes, that was a request

1	to utilize a Fire Department van, I think they
2	wanted to go to Pennsylvania. John, is it
3	does anybody have an issue with that?
4	TRUSTEE REARDON: No. Page 18
5	MAYOR BEACH: Having a company golf outing
6	and they want to use one of our vehicles to take
7	them there, which I think it actually safer.
8	TRUSTEE REARDON: So moved.
9	DEPUTY MAYOR HAWXHURST: So moved.
10	TRUSTEE BOCCIO: Second.
11	MAYOR BEACH: All in favor?
12	(Whereupon, a vote of aye was heard.
13	After, the following ensued.)
14	MAYOR BEACH: Back to the appointment of a
15	Town Clerk, we have two candidates, both have
16	been approved by the Office of Personnel that
17	interviewed them.
18	I would just like to personally interview
19	them myself and have the authorization to hear
20	which best fits the assignment.
21	DEPUTY MAYOR HAWXHURST: So moved.
22	TRUSTEE BOCCIO: Second.
23	MAYOR BEACH: All in favor?
24	(Whereupon, a vote of aye was heard by all
25	Board Members. After, the following ensued.)

1	MAYOR BEACH: Thank you.
2	The Kiwanis, they rescinded.
3	TRUSTEE REARDON: Rescinded.
4	MAYOR BEACH: 5-A is the garage doors, this
5	is the repair of garage doors down at DPW.
6	It was estimated to cost us three hundred
7	and fifty thousand dollars.
8	There are two bids that came in, John, just
9	the one bid?
10	VILLAGE ADMINISTRATOR GIORDANO: Two bids.
11	MAYOR BEACH: Two bids finally came in and
12	the bid that won is was two hundred and eighty-
13	eight thousand nine hundred and sixty.
14	A Motion to approve?
15	TRUSTEE BECKER: So moved.
16	TRUSTEE BOCCIO: Second.
17	MAYOR BEACH: All in favor?
18	(Whereupon, a vote of aye was heard. After,
19	the following ensued.)
20	MAYOR BEACH: Computer Maintenance Agreement
21	with Total, I believe it was a bid, also, John,
22	they won the bid, also.
23	VILLAGE ADMINISTRATOR GIORDANO: Yes.
24	MAYOR BEACH: We are very happy with Total,
25	their performance in the past, so, I would

1	recommend to continue with Total.
2	TRUSTEE REARDON: So moved.
3	DEPUTY MAYOR HAWXHURST: Second.
4	MAYOR BEACH: All in favor? Page 20
5	(Whereupon, a vote of aye was heard.
6	After, the following ensued.)
7	MAYOR BEACH: Then, we have a sale of the
8	surplus vehicles.
9	There were four vehicles, I believe, yes,
10	two of them sold and the other two, no bids on
11	them.
12	So, they will go to junk and I just need a
13	Motion to move this forward.
14	DEPUTY MAYOR HAWXHURST: So moved.
15	TRUSTEE REARDON: Second.
16	MAYOR BEACH: All in favor?
17	(Whereupon, a vote of aye was heard.
18	After, the following ensued.)
19	MAYOR BEACH: A couple of weeks ago, I met
20	with the Nassau County Fire Service in Lynbrook in
21	our Headquarters.
22	They had everyone from the $4^{ m th}$ Battalion and
23	they were talking with Mutual Aid for Long Island
24	and, um, they are looking for our Village to
25	participate and the purpose of the Mutual

Aid plan is to provide assistance and protection
for all communities within Nassau County and the
cause of a fire or other emergencies in which the
services of equipment and firefighters would be $\frac{\text{Page} 21}{2}$
used and to cooperate and act in accordance with
the State and Local Codes, additionally, the
County Mutual Aid Plan formulates a plan to
respond to New York City and Suffolk County Mutual
Aid Plan also requires is required by New York
State Law.

So, this is a plan that has been updated, some of it was simply utilized back in 9/11 and then, also, Superstorm Sandy.

So, it was time to be updated.

I would recommend that our Village joins this and participates in it and this would be completely up to this Board to participate in the time of the actual occurrence if there is a situation where we were involved where we need help and we needed to extend it to someone else for help.

It would be up to us to make that decision, as far as we are not obligated, let me just say it that way, to help out if we are busy ourselves.

I need a Motion to accept.

1	DEPUTY MAYOR HAWXHURST: So moved.
2	TRUSTEE REARDON: Second.
3	(Whereupon, a vote of aye was heard except
4	from Trustee Becker. After, the following $\overline{ ext{Page} 22}$
5	ensued.)
6	TRUSTEE BECKER: One quick question, this
7	has a lot to do with our Fire Department and our
8	own Office of Emergency Management, um, would it
9	be in our interest to discuss this with the Fire
10	Department and make sure they are onboard?
11	MAYOR BEACH: As I said, I was involved
12	with a Meeting with Nassau County Fire Services.
13	It is a Mutual Aid Plan with the $4^{ m th}$
14	Battalion.
15	The $4^{ ext{th}}$ Battalion incurs all the areas
16	surrounding us, among the Fire Departments;
17	Rockville Centre, um, Hempstead, the local Fire
18	Departments around us, they are all involved with
19	it.
20	This is a Statewide thing.
21	TRUSTEE REARDON: So our Fire Department is
22	in support and well aware of what is going on.
23	MAYOR BEACH: Oh, absolutely.
24	TRUSTEE REARDON: Okay, thank you.
25	MAYOR BEACH: Was the vote confirmed?

1	TRUSTEE BECKER: I didn't vote.
2	VILLAGE ADMINISTRATOR GIORDANO: Yes, it
3	was.
4	MAYOR BEACH: Okay, next is the replacement $^{ ext{Page} 23}$
5	of Village Hall doors.
6	We have had two businesses come in. There
7	were not three.
8	The front doors on this building have been
9	a nuisance, always breaking.
10	TRUSTEE REARDON: Yes.
11	MAYOR BEACH: I am requesting to finally
12	replace them with new doors.
13	We have a bid of eleven thousand dollars
14	and six hundred and nine dollars to replace them.
15	They will be doors similar to what is being
16	utilized at the Lynbrook Library. Any questions?
17	TRUSTEE BECKER: Mr. Mayor, one of the
18	issues that we have talked about a lot on the
19	Board is the security of the building, here, um,
20	with the new doors, um, has anybody looked into or
21	was it part of the process of getting bids to
22	determine if the doors could provide additional
23	security measures?
24	MAYOR BEACH: As far as the existing doors
25	there, now, are broken.

1	What additional security measures would you
2	like those doors to do?
3	TRUSTEE BECKER: It would seem to me that
4	$\overline{\text{Page} 24}$ right, now, there is no security at the doors and,
5	um, – –
6	MAYOR BEACH: At what point is there no
7	security?
8	TRUSTEE BECKER: At the entries of the
9	doors and, obviously, the vestibule doors, I am
10	just throwing it out there.
11	It would probably be a good idea to see if
12	we can invest money to see if there is any way
13	that we could provide additional security to the
14	occupants in the building for our employees.
15	MAYOR BEACH: Suggest something.
16	TRUSTEE BECKER: I mean, obviously, some
17	basic one would be a buzzer of some sort to
18	provide a buzzer so people can get buzzed in.
19	I don't know if that is practical or not,
20	I mean during COVID-19, I am sure it would be, you
21	know, the amount of visitors to Village Hall has
22	been cutdown dramatically but, certainly putting
23	an intercom system there with buzzers there where
24	people could be buzzed in and they could be viewed
25	on the camera.

8	Amanda down at the Rec. Center, "This letter is a
9	formal request for a Leave of Absence from my

11	beginning September 18^{th} and continuing to June of
12	2021."
13	Um, according to Civil Service Law, she is
14	allowed to, um, take a Leave of Absence of up to a
15	year, correct, John?
16	VILLAGE ADMINISTRATOR GIORDANO: Yes.
17	TRUSTEE BECKER: So moved.
18	TRUSTEE BOCCIO: Second.
19	DEPUTY MAYOR HAWXHURST: John, just a
20	question, do we need a reason for the Leave of
21	Absence?
22	VILLAGE ADMINISTRATOR GIORDANO: I am
23	sorry?
24	DEPUTY MAYOR HAWXHURST: Do we need a
25	reason for the Leave of Absence?

1	VILLAGE ADMINISTRATOR GIORDANO: No.
2	DEPUTY MAYOR HAWXHURST: My only concern is
3	that if someone is taking a Leave of Absence
4	because they are taking another job. Page \mid 27
5	Um, what is the what happens if
6	they don't like the other job and want to come
7	back, now?
8	VILLAGE ADMINISTRATOR GIORDANO: They are
9	entitled to come back, the position is open.
10	DEPUTY MAYOR HAWXHURST: We can fill the
11	position there?
12	VILLAGE ADMINISTRATOR GIORDANO: If they
13	don't return to work by the end of their Leave of
14	Absence, you fill the position.
15	They can't get their position back.
16	DEPUTY MAYOR HAWXHURST: Otherwise we have

25	Leave of Absence is that like a quarantee that a

1	person will have a job when they come back?
2	VILLAGE ADMINISTRATOR GIORDANO: Yes.
3	MAYOR BEACH: And if we hire someone
4	temporarily, say we go out and hire someone $ ext{Page} 29$
5	tomorrow to fill her spot, it would only be
6	temporarily and they would have to relinquish that
7	when she came back?
8	VILLAGE ADMINISTRATOR GIORDANO: Yes.
9	MAYOR BEACH: Do you want to check with the
10	Union, first?
11	DEPUTY MAYOR HAWXHURST: I kind of want
12	more information on that. I want to know whether
13	or not if it doesn't prohibit us, I would like a
14	little more information.
15	I am concerned if we hire someone
16	temporarily and they are good
17	MAYOR BEACH: You are right one hundred
18	percent.
19	Mike, you are right.
20	DEPUTY MAYOR HAWXHURST: Nothing against
21	the person who is asking for the Leave of Absence
22	but, you know, I don't believe we are set up so
23	that they can try another job and come back.
24	You know, would like to get the Union's
25	view on this.

1	TRUSTEE REARDON: Yeah.
2	DEPUTY MAYOR HAWXHURST: I would really
3	hate to hire someone and especially, if they are
4	$_{ m page} 30$ good and then, basically, come June and this other
5	person wants to come back because they didn't like
6	working in a neighboring place and, then, we have
7	to kick that person out.
8	It just doesn't seem a fair reason to grant
9	a Leave of Absence.
10	MAYOR BEACH: So, how about if we table it
11	and verify everything for the next Board Meeting.
12	VILLAGE ADMINISTRATOR GIORDANO: Yes.
13	TRUSTEE BOCCIO: I make a Motion to table
14	it.
15	TRUSTEE REARDON: That I will second.
16	(Whereupon, a vote of aye was heard.
17	After, the following ensued.)
18	TRUSTEE BECKER: Mayor, if I could ask a
19	question on that, so does this fall under the
20	Family Leave Act, John or something outside of the
21	Family Leave Act?
22	VILLAGE ADMINISTRATOR GIORDANO: She didn't
23	give a reason.
24	TRUSTEE BECKER: And, you mentioned
25	something about Civil Service at the beginning.

1	VILLAGE ADMINISTRATOR GIORDANO: Well
2	actually she is a Member of the UPSU Union and
3	in the Union agreement, she is entitled to ask
4	for a Leave of Absence but it is up to the Board's
5	discretion.
6	MAYOR BEACH: She is entitled to ask not
7	necessarily okay, I was under the impression
8	she was able to have it, okay, all right.
9	Next is the bills, please.
10	TRUSTEE BOCCIO: Yes, Mr. Mayor, I move
11	that the bills listed on the abstract and audited
12	vouchers be paid as soon as they have been duly
13	audited by the Majority.
14	TRUSTEE REARDON: Second.
15	MAYOR BEACH: All in favor?
16	(Whereupon, a vote of aye was heard.
