1	MAYOR BEACH: Good Evening, everyone and
2	welcome to the Board Meeting of June $7^{ m th}$.
3	I will ask John Giordano to lead us in the
4	Pledge of Allegiance.
5	VILLAGE ADMINISTRATOR GIORDANO: Right hand
6	over your heart.
7	(Whereupon, John Giordano, the Village
8	Administrator led the Assembly in the Pledge of
9	Allegiance. After, the following ensued.)
10	MAYOR BEACH: Once, again, good evening,
11	everyone and welcome to the Meeting.
12	There is a little bit of feedback with the
13	mics, will that fade?
14	I will move and see how it works out.
15	First on the agenda is the Minutes of May
16	$17^{ m th}$ has the Village Board read the Minutes?
17	(Whereupon, "yes" was heard by all. After,
18	the following ensued.)
19	MAYOR BEACH: Are there any changes?
20	(Whereupon, "No, Mayor," was heard. After,
21	the following ensued.)
22	MAYOR BEACH: I will accept a Motion to
23	accept the Minutes of May 17^{th} .
24	TRUSTEE REARDON: So moved.
25	TRUSTEE BOCCIO: Second

1	MAYOR BEACH: All those in favor?
2	(Whereupon, a vote of aye was heard by all.
3	After, the following ensued.)
4	MAYOR BEACH: Next on the agenda is the
5	Board Meeting for the Summer season. I do have a
6	problem with those dates.
7	There is July 19^{th} , August 16^{th} and
8	September 13 th .
9	I have a problem with August 16 th .
10	Can we make it to the $23^{\rm rd}$, that would be
11	the week after?
12	DEPUTY MAYOR HAWXHURST: Fine.
13	MAYOR BEACH: Ann Marie?
14	TRUSTEE REARDON: The carnival?
15	MAYOR BEACH: Ann Marie, we are live.
16	DEPUTY MAYOR HAWXHURST: August 16th to
17	August 23 rd .
18	MAYOR BEACH: August 16th to August 23rd,
19	you don't have an issue with that?
20	TRUSTEE REARDON: No.
21	TRUSTEE RYDER: No problem.
22	MAYOR BEACH: A Motion to have the Meetings
23	July $19^{\rm th}$, August $23^{\rm rd}$ and September $13^{\rm th}$ for the
24	Summer session?
25	TRUSTEE BOCCIO: So moved.

1	TRUSTEE RYDER: Second.
2	MAYOR BEACH: All in favor?
3	(Whereupon, a vote of aye was heard by all.
4	After, the following ensued.)
5	MAYOR BEACH: I hope the next goes a little
6	bit easier.
7	Next on the agenda is the carnival, Titans
8	football would like to have another carnival.
9	I think they had one a couple of years ago,
10	correct and they really did a nice job.
11	It was over by the hockey rink. It was
12	kind of secluded over there.
13	And, it was fences around, so, we could
14	maintain what was going on there and the police
15	were there with their bicycles maintaining the
16	whole area.
17	It is very safe over there.
18	It is for the children and I thought it was
19	a great thing that they did.
20	Um, the have their carnival agreement and
21	their insurance Certificate of Liability.
22	Does anybody have a problem with that?
23	(Whereupon, "no" was heard by all. After,
24	the following ensued.)
25	DEPUTY MAYOR HAWXHURST: Just one question

1	for the Inspector; was there any issues last time
2	with the carnival?
3	INSPECTOR: No.
4	DEPUTY MAYOR HAWXHURST: Okay.
5	MAYOR BEACH: That would be the carnival
6	set for July 8^{th} through the 11^{th} .
7	I need a Motion.
8	DEPUTY MAYOR HAWXHURST: SO moved.
9	TRUSTEE REARDON: Second.
10	MAYOR BEACH: All in favor?
11	(Whereupon, a vote of aye was heard by all.
12	After, the following ensued.)
13	MAYOR BEACH: Great.
14	Next is the Lynbrook High School, June 22^{nd} ,
15	they want to have the Prom Walk at Greis Park,
16	normally we do it on the Avenue, but, the way
17	things go so mixed up in the past year that they
18	thought it would be a good location as things are
19	working out, it works out well for them.
20	So, that would be on the 22^{nd} . 5:30 to 6:30
21	is the Prom Walk and the Pool would be after that,
22	that is the second part of the agenda, correct?
23	TRUSTEE REARDON: Yes.
24	MAYOR BEACH: I will ask for a vote for
25	both of them.

1	Do you have issues with any of them?
2	DEPUTY MAYOR HAWXHURST: The pool,
3	actually, they have the wrong date on, here
4	because it is after midnight, it is actually on
5	the 23^{rd} , not the 22^{nd} .
6	MAYOR BEACH: The pool?
7	TRUSTEE REARDON: Yes.
8	DEPUTY MAYOR HAWXHURST: From 12:00 to
9	3:30.
10	MAYOR BEACH: So, a Motion?
11	TRUSTEE REARDON: So moved for both the
12	Pre-Prom Walk and the Post-Prom Pool.
13	MAYOR BEACH: Second?
14	TRUSTEE RYDER: Second.
15	MAYOR BEACH: All in favor?
16	(Whereupon, a vote of aye was heard by all.
17	After, the following ensued.)
18	MAYOR BEACH: There has been an add-on,
19	here, for a banner display.
20	Rob, do you know more about this?
21	TRUSTEE BOCCIO: Yes.
22	Lynbrook/East Rockaway Soccer Club is
23	looking to put up typically, they do a banner
24	running from June $9^{ ext{th}}$ to August $8^{ ext{th}}$ for the Fall
25	registration.

1	They have indicated what the size will be.
2	It is the same as the previous time and
3	over by Horton
4	MAYOR BEACH: Horton and Scranton?
5	TRUSTEE BOCCIO: West corner of Horton and
6	Scranton.
7	MAYOR BEACH: Ocean Avenue.
8	TRUSTEE BOCCIO: And, Ocean Avenue, as
9	well.
10	MAYOR BEACH: I don't have a problem with
11	that.
12	A Motion?
13	DEPUTY MAYOR HAWXHURST: One quick second;
14	where on Ocean is it?
15	TRUSTEE BOCCIO: It is over by the Field of
16	Dreams.
17	MAYOR BEACH: Ocean and Lakeview.
18	DEPUTY MAYOR HAWXHURST: Okay.
19	TRUSTEE BOCCIO: It is right where there is
20	one, now.
21	DEPUTY MAYOR HAWXHURST: Yep, yep, that is
22	fine.
23	MAYOR BEACH: Right where there is one,
24	now?
25	TRUSTEE BOCCIO: Yeah, there was.

1	MAYOR BEACH: Without a permit?
2	TRUSTEE BOCCIO: No, it was approved last
3	time.
4	MAYOR BEACH: So, I need a Motion.
5	TRUSTEE REARDON: So moved.
6	TRUSTEE BOCCIO: Second.
7	MAYOR BEACH: All in favor?
8	(Whereupon, a vote of aye was heard by all.
9	After, the following ensued.)
10	MAYOR BEACH: There is another add-on, rain
11	date if possible, considering for permission to
12	use Greis Park for the Lynbrook, I guess from the
13	PTA, again, Lynbrook Senior Barbecue.
14	The PTA requests to use Greis Park on
15	Thursday, June $17^{\rm th}$ from 3:30 to 6:30 for barbecue
16	for the Senior Class of Lynbrook High School.
17	It is opened to all Seniors and PTA Members
18	and School Staff as Chaperones.
19	Motion?
20	TRUSTEE RYDER: So moved.
21	TRUSTEE BOCCIO: Second.
22	MAYOR BEACH: All in favor?
23	(Whereupon, a vote of aye was heard by all.
24	After, the following ensued.)
25	MAYOR BEACH: There are no other add-ons,

1 are there, that is it. 2 Next on the Agenda is Number 4 on the 3 Agenda. Decision on the application for multi-4 5 family housing and Cultural Art District, 47 6 Broadway, 90-96 Saperstein Plaza, 15-21 Langdon 7 Place. 8 We had the Hearing on the 17th. I just have 9 a little history on this property. 10 Since 2005, the Village Board has been 11 aggressively trying to find someone who would 12 actually develop this property known as the 13 "Feather Factory." 14 And, we have always had the issue of 15 parking being a problem. 16 When I became Mayor, I have to tell you, I 17 immediately called Mr. Singer, the owner of the 18 property of the Feather Factory because, quite 19 honestly, I couldn't stand look at that building 20 and how it is in disrepair and it makes our 21 Village look really terrible. 22 And, actually, I had a very nice 23 conversation with Mr. Singer at the time and he 24 received my phone call rather nicely that he came

25

in.

1	We sat down and we talked and the
2	conversation went on for some time but he began
3	negotiating for the property, so, that brings us
4	to the point well, let me put it this way, it
5	has been a very long journey.
6	Fifteen years and four Mayors, it started
7	with Gene Scarpato, that building.
8	I would like to ask the Village Board if
9	there is any comments before we move forward with
10	the vote and if anybody else has anything they
11	want to say about the building.
12	Laura, I will start with you.
13	TRUSTEE RYDER: I just jotted down some
14	thoughts.
15	MAYOR BEACH: Sure.
16	TRUSTEE RYDER: At this time, with this
17	vote that we are going to take, I believe that
18	Lynbrook is facing a tremendous opportunity with
19	this proposal and opportunity for a hundred
20	million dollars to be invested in our community.
21	And, how often has that happened?
22	I don't know of anyone
23	MAYOR BEACH: Not in my lifetime.
24	TRUSTEE RYDER: Nor mine.
25	And, I believe that this proposal brings

many other opportunities to Lynbrook, as well.

Number 1, as you stated, Mr. Mayor, is to get that terrible eyesore that has been a blight to our downtown and replace it with the state-of-the-art, upscale, tax generating residential building which will provide a desired housing option for two categories of people as the Developer presented, mostly two.

One would be Millennials that don't want to invest in the housing market at this point in their lives and secondly, would be retirees, who, perhaps want to downsize but stay in the community and those are the people that we want to keep; our retirees, here.

This project will also enhance the Village's overall fiscal health and tax base. I believe this project will also contribute to the vibrancy of our downtown and grow the market for commercial uses.

But, most importantly, I believe this project will give Lynbrook a vibrant and welcoming identity enabling us to evolve and meet the challenges of the future.

This transit-oriented development is the way of the future and we don't want Lynbrook

left behind.

We must be forward thinking and embrace this opportunity that is before us.

MAYOR BEACH: Thank you.

Trustee Boccio?

TRUSTEE BOCCIO: A lot of stuff Laura said,

I think is appropriately on point.

It is a tremendous opportunity.

It is a massive investment. Clearly, one of the things we need to be looking at is the generation of business and multiplier affect that we hope that will come out of this by helping our downtown and addressing the issues that we see with some of the vacancies.

And, I think this is going to be able to inject that kind of investment in our businesses, help further attract and I think it is a great opportunity and I think at the end of the day, it is going to be something that we believe is going to further jumpstart what we already started to see is that to be in Lynbrook and with the proximity to the beaches, with the proximity to the City, this is a place that people need to be and I think this is going to help attract businesses even further.

1 MAYOR BEACH: Thank you. 2 Deputy Mayor? 3 DEPUTY MAYOR HAWXHURST: Thank you, Mayor. 4 You know, being on this Board for the past 5 twelve years, we have seen a lot of different 6 things come and go, being presented for that 7 building, everything from, at one time, the Board 8 considering taking by eminent domain, which our 9 lawyer at the time told us would be a financial 10 disaster for the Board. 11 That lawyer became a Nassau County Judge 12 and was involved with the Long Beach properties 13 that they have been dealing with over the years, 14 so, he knew what he was talking about. 15 We saw everything from a hotel to a movie 16 theater to a number of different projects proposed 17 that never came to fruition. 18 I heard concerns the Village should have 19 bought the property. 20 Well, you know, Breslin Realty is investing 21 north of twelve million dollars into just buying 22 the properties there and you are looking at the 23 cost of demolition and you know, building whatever 24 you want to build.

I think this was always out of the realm

of the Village buying those properties, you know, the School District or anybody else buying those properties.

It wasn't feasible.

We saw a presentation at the last Meeting that was professional, addressed concerns that they heard from the public meetings.

You know, they had two public meetings, one with the virtual session for the residents to attend, voice their concerns, um, the presentation addressed concerns about traffic, about the schools, about parking, about the density over there, about the design of the building, about the amenities of the building.

Are there still concerns about traffic?

Yes and we are looking at other options,

also dealing with traffic over there and working

with Nassau County because of the County roads,

but, I think when you look at the project, not

this project but when you look at the development

that has been over fifteen years in the making,

you know it is not something that this Village

rushed into.

It is not something that we took the first thing that came along to us, we listened to.

1 Numerous times these were private 2 properties that developers bought at different 3 times, the private owners didn't want to sell 4 their properties. 5 So, you know this came to us and was 6 presented, you know, to the Board and the Mayor 7 has been open and transparent with what was going 8 on there, transparent into what was posted on the 9 website with regard to the documentation, the 10 studies that were done so residents could read it. 11 Transparent with the financial disclosure 12 from each of the Board Members to show that we 13 didn't have a financial interest in the properties 14 over there but I think we are looking at something 15 that is going to better our Village, an 16 opportunity for people that want to stay here 17 after selling their home and give an opportunity 18 for younger residents that want to move into this 19 Village. 20 And, you know, in that sense I think it is 21 a good step forward. 22 MAYOR BEACH: Trustee Reardon? 23 TRUSTEE REARDON: Thank you, Mayor. 24 I am actually speaking last. I am in

agreement with everyone who has spoken thus far

and it was evident after, um, the presentation and sitting through that, that these developers have looked at the concerns of the residents, the concerns of the Village and absolutely have one hundred percent investing in Lynbrook because they looked at every possibility that might be a concern or a worry.

They did listen to the people, um, and I think that is very important because they really want to be here.

Um, they want to develop, here.

They see, um, Lynbrook as a great place to live and work and raise a family which is what we have been saying for years and you know what, it is time that we do, we look at our downtown knowing it is better than nothing that all we have to do is walk down into Town and go to dinner, to some shopping and all of that and not have to get - even as homeowners, not to having to get in our car and driving somewhere, you know, I want all of that stuff here.

You know there are great possibilities for people to come to Lynbrook and I think this development is a start of bringing them here and I do think it is important step forward as Trustee

Ryder said.

You know, we need not to be behind. We need to be forward thinking and I think that is an important piece here and you know what, we did have a Public Hearing.

We had an opportunity to hear, um, from our residents and we actually heard from one who was actually able to call in, who was in support of it.

So, going off what you know the concerns are it seems to be the right step and right move forward for this Village.

Thank you.

MAYOR BEACH: Thank you, Trustee Reardon.

David Orwasher from Breslin Realty has always been a gentleman and always extended himself to have meetings whenever I asked him to.

He opened up his doors at the Knights of Columbus and had multiple meetings there, so, everyone could hear what his building would look like and any questions you had.

He had all the answers for you. And, the last Meeting was the Public Hearing, there was - - Trustee Reardon said it, there was one gentleman that called up on the phone and there were

1	Members of the Chamber that were here in great
2	support of it.
3	So, at this time, I make a Motion for
4	approval of the application as presented at the
5	Hearing on May 17^{th} regarding the multiple family
6	sue at 43-47 Broadway.
7	I need a Motion.
8	TRUSTEE REARDON: So moved.
9	DEPUTY MAYOR HAWXHURST: Second.
10	MAYOR BEACH: All in favor?
11	(Whereupon, a vote of aye was heard by all.
12	After, the following ensued.)
13	(Whereupon, applause from the audience was
14	heard. After, the following ensued.)
15	MAYOR BEACH: Pretty exciting, actually.
16	TRUSTEE REARDON: Very exciting.
17	VILLAGE ATTORNEY ATKINSON: Most
18	respectfully, I will prepare a decision for your
19	signature and get in touch with each of you.
20	MAYOR BEACH: A final decision, great, that
21	will get off to him. Thank you very much. Very
22	exciting for the Village, some movement and
23	changes we are starting off our downtown to be
24	very active.
25	Once, again, it has been a long journey

1	for all of us.
2	Next on the Agenda is Number 5, is FDIC
3	training.
4	It is in Indianapolis. It is on August 1^{st}
5	through the $7^{ ext{th}}$ and Chief Donald, respectfully,
6	requests thirteen Members to attend the FDIC-21
7	that is hands-on training preconference workshops
8	and classroom seminars in Indianapolis.
9	All funding has been provided and they
10	would like to use as transportation units, 429,
11	the Chief's vehicle and 4261 is the van.
12	I need a Motion.
13	TRUSTEE BOCCIO: So moved.
14	TRUSTEE REARDON: Second.
15	MAYOR BEACH: All in favor?
16	(Whereupon, a vote of aye was heard by all.
17	After, the following ensued.)
18	MAYOR BEACH: Thank you.
19	And, next on the Agenda is the MTA Parking
20	Agreement.
21	You know we really have taken a hit on our
22	funds at the railroad because we haven't well,
23	they have been getting beaten up too because they
24	haven't been able to have people go into the City.

1	So, and our response to inquiries, the
2	MTA has offered the following reduction to our
3	eighteen thousand nine hundred and thirty-nine
4	quarterly commuter parking lease payments to
5	account for our permit revenue losses caused by
6	COVID ridership decrease from April, 2020 to July
7	31, 2020.
8	So, the full amounts previously paid by the
9	Village will be credited to us and discount rates
10	will be in effect as regional ridership remains
11	under the seventy-five percent.
12	So, if the ridership increases over
13	seventy-five percent, our lease payments will be
14	adjusted to they are saying they are not
15	saying exactly what it will be adjusted to,
16	correct, John?
17	VILLAGE ADMINISTRATOR GIORDANO: It will be
18	back to normal.
19	MAYOR BEACH: It will be back to normal if
20	it goes over that seventy-five percent?
21	VILLAGE ADMINISTRATOR GIORDANO: Yes.
22	MAYOR BEACH: I won't go through the whole
23	thing but I want to thank John Giordano and
24	Valerie Onorato in the Office working very hard
25	and MTA working with us too.

1	And, I would like to thank President Eng
2	and Hector Garcia for reaching out to us and
3	working with us.
4	You know, Mr. Eng, the President of the MTA
5	is very helpful with this Village getting the
6	station done and they also are looking for other
7	monies to try to improve other areas of the
8	station.
9	So, we are very fortunate to have Mr. Eng
10	in Lynbrook along with Hector Garcia.
11	So, thank you to the MTA.
12	Next on the Agenda is 7, DPW and
13	Recreation.
14	DEPUTY MAYOR HAWXHURST: So moved on this
15	one.
16	MAYOR BEACH: I am sorry, I thought we
17	voted. No, okay, I get so excited. All right, a
18	Motion.
19	DEPUTY MAYOR HAWXHURST: So moved.
20	TRUSTEE BOCCIO: Second.
21	MAYOR BEACH: All those in favor?
22	(Whereupon, a vote of aye was heard by all.
23	After, the following ensued.)
24	MAYOR BEACH: I am sorry.
25	Next on the Agenda is the Seasonals for

1	Phil Healey; hiring Justin Harvin, Seasonal
2	Laborer for the Department of Public Works.
3	I need a Motion for him.
4	TRUSTEE BOCCIO: So moved.
5	TRUSTEE REARDON: Second.
6	MAYOR BEACH: All in favor?
7	(Whereupon, a vote of aye was heard by all.
8	After, the following ensued.)
9	MAYOR BEACH: Keith Bonomo, Seasonal
10	Employees at the Park; Daniel Abrams, Francis
11	Cavalli, Emma Bratichak, Mason Benvenuto,
12	Maryanna Palmieri and those are Lifeguards and
13	Rec. Attendants.
14	TRUSTEE REARDON: So moved.
15	DEPUTY MAYOR HAWXHURST: Second.
16	MAYOR BEACH: All in favor?
17	(Whereupon, a vote of aye was heard by all.
18	After, the following ensued.)
19	MAYOR BEACH: Next, we have Recreational
20	hires from Andrea; Natalie Palomino as part-time
21	Recreation Attendant.
22	She will help out down at the Rec.
23	A Motion?
24	TRUSTEE BOCCIO: So moved.
25	TRUSTEE REARDON: Second.

1	MAYOR BEACH: All in favor?
2	(Whereupon, a vote of aye was heard by all.
3	After, the following ensued.)
4	MAYOR BEACH: From Andrea, again,
5	Recreational Dance Specialist.
6	She has Elizabeth Gomez is an Education
7	Major at Hofstra University and for one of the
8	openings for the Recreation Dance Specialist

10	Her rate will be eighteen dollars an hour
11	and she has her resume attached to this.
12	TRUSTEE REARDON: So moved.

14	MAYOR BEACH: All in favor?
15	(Whereupon, a vote of aye was heard by all.
16	After, the following ensued.)
17	TRUSTEE RYDER: She has a very impressive
18	resume, very impressive.
19	I think she will be a good addition.
20	TRUSTEE REARDON: Add-on Lifeguards, Mayor,
21	Emma Anderson, Jaderlin Abreu, Thomas Atkinson.
22	MAYOR BEACH: I have it, here. It fell
23	off.
24	A Motion.
25	TRUSTEE REARDON: So moved.

1	DEPUTY MAYOR HAWXHURST: Second. Our
2	Attorney will be a Lifeguard, too.
3	MAYOR BEACH: Yes, yes.
4	TRUSTEE REARDON: He is bringing back the
5	speedo.
6	TRUSTEE BOCCIO I was going to stay away
7	from that.
8	TRUSTEE REARDON: I went right there.
9	VILLAGE ATTORNEY ATKINSON: The lawyers
10	that I meet, I say I am a Lifeguard for more years
11	than I admit professional.
12	MAYOR BEACH: Let's leave the speedo out of
13	it.
14	TRUSTEE REARDON: So moved.
15	DEPUTY MAYOR BEACH: Second.
16	MAYOR BEACH: All those in favor?
17	(Whereupon, a vote of aye was heard.
18	After, the following ensued.)
19	TRUSTEE RYDER: I recuse myself on Thomas
20	Atkinson, aye to the others but he knows how I
21	feel.
22	MAYOR BEACH: Next on the Agenda is the
23	improvements, the road drainage at do you have
24	it?
25	Thanks. (Handing documents.)

1	MAYOR BEACH: Two intersections, they will
2	fill with the CHIPS money.
3	It was Stevenson and Highland and Village
4	Avenue and Chester Street.
5	All right, it is thirty-eight thousand
6	dollar project and it will be reimbursed under the
7	CHIPS Program.
8	A Motion?
9	TRUSTEE REARDON: So moved.
10	TRUSTEE RYDER: Second.
11	MAYOR BEACH: All those in favor?
12	(Whereupon, a vote of aye was heard by all.
13	After, the following ensued.)
14	MAYOR BEACH: Thank you.
15	And, then, "B" is the 911 Memorial.
16	The 911 Memorial, the bricks we noticed
17	need to be repaired so Mr. Healey has approached
18	us and asked us to get new bricks for the people,

8	After, the following ensued.)
9	MAYOR BEACH: The amendment of the Vehicle
10	and Traffic Code to amend parking.
11	I think this may be better to table.
12	DEPUTY MAYOR HAWXHURST: So moved.
13	TRUSTEE BOCCIO: Second.
14	MAYOR BEACH: All those in favor?
15	(Whereupon, a vote of aye was heard by all.
16	After, the following ensued.)
17	MAYOR BEACH: And, then, we have the bills.
18	TRUSTEE RYDER: I move that the Bills
19	listed on the abstract of the audited vouchers be
20	paid as soon as they have been duly audited by the
21	majority.
22	MAYOR BEACH: Second?
23	TRUSTEE BOCCIO: Second.
24	MAYOR BEACH: All those in favor?
25	(Whereupon, a vote of aye was heard

1 by all. After, the following ensued.) 2 MAYOR BEACH: I will go down the line. 3 Do you have anything to say? 4 TRUSTEE RYDER: I just wanted to mention 5 one thing, that the Community Chest has received a 6 donation, today or recently, from Chris Anderson 7 and Crown Ford for five thousand dollars. 8 MAYOR BEACH: Woe. 9 TRUSTEE RYDER: Extremely, extremely 10 generous. 11 Chris has been wonderful and he had reached 12 out to me a few years back saying that, um, every 13 dealership, Crown Ford Dealership is given the 14 opportunity to donate to the Community a certain 15 amount and, um, he had reached out to me and 16 wanted years ago, a few years a go and wanted to 17 have some information about the Community Chest. 18 So, we had a very nice conversation. 19 I just told him, in general terms, the work 20 that the Community Chest has done and he decided 21 to make the Lynbrook Community Chest a recipient 22 of his donation. 23 So, once, again, the Community Chest has 24 received a five thousand dollar donation and I

INSPECTOR: They are very talented, I must say, you know, well, really, it is a very dangerous activity that they are participating in.

The Police Department is taking it very seriously and we are trying not only to enforce the law but also educate them as to why these sorts of activity would not be beneficial, also, now, that COVID restrictions are lessening.

We will have our SRO go into the schools and educate them directly as to the repercussions of their activities.

And, um, for the parents watching us, tonight, please, just, you know, stress to your children it is a problem, um, not only for you know, pedestrian traffic but also vehicular traffic and we will go be out in force making sure these activities don't occur.

Um, secondly, while I am up, here, the fireworks have become a complaint, as everyone is probably aware, we have gotten many callers, not recently, but especially last 4th of July in regard to fireworks, um, and the noise that they emit and the detrimental affects they have with the residents.

We will be out, not only July 4th but the

1 Weekends leading up to it and after it making sure everyone celebrates. 2 3 We want everyone to celebrate but we want 4 them to do so safely and legally as well so that 5 is another concern for anyone watching us, be 6 advised we are certainly addressing the situation. 7 And, lastly, we have a Facebook page. 8 It is called "Lynbrook Community Police 9 Outreach" and if you know you are wondering what 10 is going on with the Police Department and what we 11 are doing and things we want to convey to you. 12 It is a great informational site. 13 We are trying to get a few more "likes" and 14 followers, so, if you are not already "liking" or 15 "following" our Page, I would appreciate if you do 16 so. 17 It is a great way for us to communicate and 18 if you have something that you want to share with 19 us, you can do so through the Face book Page or 20 call us as always. 21 MAYOR BEACH: Thank you very much. 22 appreciate it, Inspector. 23 Any other comments? 24 DEPUTY MAYOR HAWXHURST: No, I think to 25 follow up on Inspector's talk about the

1	Facebook Page, I think we saw last Summer many of
2	our Police Officers enjoy stopping at local
3	lemonade stands, you know, please inform the
4	Inspector of them through the Facebook Page and
5	they will highlight it on their Face book Page.
6	MAYOR BEACH: All right, thank you. Close
