The Mayor congratulated Richard Fasano on his election as Village Justice who begins his term on April 7th, to replace William McLaughlin who retired on March 31, 2025. The Mayor also thanked Associate Justice Brendan Hughes, who retired on March 19, 2025, for his many years of service. To accommodate the succession and transition of Justices, the Mayor appointed former Justice William McLaughlin as Associate Justice to fill the unexpired term of Brendan Hughes ending April 7, 2025, effective immediately. The Mayor thanked Justice McLaughlin for his 25 years serving the Court, and moved that his existing Dental and Optical Insurance be continued by the Village, such provision to not set precedent with future Associate Justices, and seconded by Trustee Boccio. Motion carried, all voting "Aye".

The Mayor also reported that since Court trials have been scheduled for April 2nd, he has requested Associate Justice McLaughlin to return from vacation out of state to serve on April 2nd. It was moved by Mayor Beach, seconded by Trustee Habert, to reimburse Associate Justice McLaughlin travel expenses not to exceed \$375 to accommodate this exigent matter.
