Fireproofing over the boiler shall extend from brick chimney to a point not less than three feet forward of burner unit, and shall extend not less than three feet on both sides of boiler or furnace. Safety relief valve must be installed on all new and old installations domestic hot water tanks. Any carbon producing unit requires a smoke and carbon monoxide detector as per New York State Code.

All boilers must meet manufacturing specifications and New York State Code.

All water pipe connections, hot-water boiler connections or any kind of plumbing requires a plumber that is **Registered & Licensed in the Village of Lynbrook.**

**Plumber must be on site for inspections - Any questions contact the plumbing inspector**

Applicant certifies that all information given is correct, that the plumber of record will be completing all work and that all pertinent mechanical ordinances will be complied with in performing the work for which this permit is used or summonses will be issued.
