

ITEMS NECESSARY FOR A PLUMBER'S LICENSE

1. Application completed and notarized.
2. Liability insurance (See attached)
3. Compensation Insurance Certificate made out to the Inc. Village of Lynbrook. If you employ no help, then you must submit the for CE-200 from the NYS Worker's Compensation Board. ***AFFIDAVITS & ACORD FORMS ARE NO LONGER ACCEPTABLE.***
4. If you intend to do sewer work, then a Bond in the amount of \$2,000 must be submitted.
5. Copy of Current License (Receipts or Registration Cards will NOT be accepted)
6. Copy of Certificate of Competency (See attached)
7. Letter of Good Standing from Town/Municipality where plumber is licensed.
8. Fee: New Plumber: \$200 for a TWO YEAR LICENSE
Existing Plumber: \$150 for a TWO YEAR RENEWAL LICENSE

Certificate of Competency & Current License must be from the same village/township.
